CDOT High-Performance Transportation Enterprise

Ms. Megan Castle, Colorado Department of Transportation, presented information on the North I-25 Express Lanes. Ms. Castle provided information about how to use the new express lanes, the connections to I-25, and the tolls for use of the lanes. Ms. Castle spoke ExpressToll stickers and switchable HOV transponders for the new lanes and answered questions regarding fees and the availability of the HOV transponders.

Economic Development Update

City Manager Hayes reported a copy of a Justice Assistance Grant had been distributed to Council and asked Council to send comments regarding the grant to him.
