


#### **COVID-19 UPDATE**

What determines your county's level of protection?


- **Percent of positive cases**: percent of tests that come back positive out of the total number of tests performed. The global standard to ensure that we are doing enough testing is a percent positivity of less than 5%
- Amount of cases in a two-week period: The 2-week incidence, per 100,000 populations helps us understand how much the virus is circulating in a community.
- Stable or declining hospitalizations: One of our key goals is to ensure that every person who needs hospital care can receive it. Stable is defined as no greater than 25% increase in a county's referral hospitals or no more than 2 new hospital admissions with COVID-19 on a single day, in the past 14 days.

### Hospital capacity risks have been breached, which may be indicated by:

- Approaching the need for medical crisis standards of care
- · Utilizing alternative care sites
- · Critical shortages of PPE or staff
- Hospitals approaching 90% of their reported surge capacity










Counties will move between levels based on the metrics and will work with the state to ensure unique local factors are considered. In order to move to a less restrictive level (e.g., Level 2 to Level 1), counties must meet and sustain all three metrics for two weeks. Counties must engage in a consultation process with CDPHE, which may entail moving to a more restrictive level, when they are out of compliance with any of the metrics for more than two weeks.

# LEVEL RED: SEVERE RISK

CATEGORY	PREVIOUS	CURRENT
Personal Gathering Size	Up to 10 from no more than 2 households	None
Restaurants – Indoor	25% capacity or 50 people	Closed
Last Call	10pm	8pm
Gyms/Fitness	25% capacity, 25 indoors or outdoors in groups less than 10	10% capacity, 10 indoors per room or outdoors in groups less than 10. Reservations required.
Offices	25% capacity	10% capacity
Personal Services	25% capacity or 25 people	25% capacity or 25 people
Critical and Non-critical Retail	50% capacity	50% capacity
Childcare	Open	Open

### RECREATION CENTER

- Recreation Center is open for limited programming such as private swim lessons, lap swim, aquafit, fitness classes, cardio and weight equipment. Participants must make an appointment to participate in classes. We are only allowed up to 10 participants per room.
- Offering virtual fitness programming
- Senior Center is open for 1 on 1 personal services.
  Appointments are required.
- Remote learning at the recreation center
- Adult and youth sports leagues are canceled.
- Parks, Trails and Open Spaces are open.
