SUBJECT:

CB-1921 - Pawnbroker Regulations

PURPOSE

To consider an ordinance amending Chapter 18, Article 3 of the Municipal Code regarding pawnbroker regulations.

The proposed ordinance:

- Allows pawnbroker businesses to operate on Sundays.

Allows pawnbroker businesses to operate on holidays.

- Revises language regarding the fee a pawnbroker can charge a person to retrieve a pawned item to be consistent with State law.

BACKGROUND

Pursuant to Northglenn Municipal Code § 18-3-17, it is unlawful for any pawnbroker to operate during the following hours and on the following days:

- (1) After 9:00 p.m. and before 8:00 a.m.
- (2) On Sunday.
- (3) On January 1, commonly called New Year's Day; on the last Monday of May, commonly called Memorial Day; on July 4, commonly called Independence Day; on the first Monday of September, commonly called Labor Day; on Thanksgiving Day; and on December 25, Christmas Day.

The City exercised its local authority to license and regulate pawnbroker businesses in 1995 by the adoption of Ordinance No. 1131. The hour and day restrictions above were adopted at that time and have not been amended since then.

At a study session on January 28, 2019, staff presented a request from a lobbyist representing a local pawnbroker to allow pawnbroker businesses to be open on Sundays. Staff also requested Council to consider removing the restriction which prohibits pawnbroker businesses from operating on certain holidays. It was the consensus of Council to move forward with the request and a proposed ordinance, CB-1921, was presented to Council on first reading at the February 11, 2019 regular meeting.

The table on the following page provides information about other cities' regulations related to pawnbroker hours and permissible days of operation. Most pawnbroker businesses across the metro area close at 6:00 p.m. or 7:00 p.m. even if their municipality allows later operating hours.

While reviewing the current pawnbroker ordinance, staff determined that language regarding the fee a pawnbroker can charge a person to retrieve a pawned item is inconsistent with State law. This fee is also known as a "fixed price." Specifically, Section 18-3-14(g) of the Northglenn Municipal Code contains an amount a pawnbroker may charge that is more restrictive than State law, which is prohibited by C.R.S. § 29-11.9-102. Therefore, a revision is necessary to be consistent with State law. The new language will establish a fee that is the same, or as restrictive, as the State's definition of "fixed price."

Current "fixed price" Not to exceed one-tenth of the original purchase price for each

month, plus the original purchase price on amounts of \$50 or over, or one-fifth of the original purchase price for each month, plus the original purchase price for each month, plus the original purchase

price, on amounts under \$50.

Proposed "fixed price" Not to exceed one-fifth of the original purchase price for each

month, plus the original purchase price.

STAFF RECOMMENDATION

Staff recommends approval of CB-1921.

BUDGET/TIME IMPLICATIONS

No budget implications have been identified. If CB-1921 is adopted on second reading, the ordinance will become effective five days after publication.

(g) No pawnbroker, employee, or agent of the pawnbroker shall ask, demand or receive any greater rate of interest, commission and compensation than the total rate of one-tenth (1/10th) of the original purchase price for each month, plus the original purchase price, on amounts of fifty dollars (\$50.00) or over, or ENTER INTO A CONTRACT WITH A CUSTOMER CONTAINING AN AGREED UPON AMOUNT TO CANCEL THE CONTRACT EXCEEDING one-fifth (1/5th) of the original purchase price for each month, plus the original purchase price for each month, plus the original purchase price, on amounts under fifty dollars (\$50.00). No other charges shall be made by the pawnbroker upon renewal of any contract for purchase or at any other time. In the event any such charges are made, the contract shall be void. Any contract for the payment of commissions by the customer for making a contract for purchase of tangible personal property shall be null and void. The violation of the Section by an agent, or employee of a pawnbroker shall be deemed to be a violation of this Section by the pawnbroker. Section 18-3-17 of the Northglenn Municipal Code is hereby amended to Section 2. read as follows: Section 18-3-17. Hours of Pawnbrokers. It shall be unlawful for any pawnbroker to operate during the following hours and on the following days: (1) After 9:00 p.m. and before 8:00 a.m.

(2) On Sunday.
