## **AGREEMENT**

THIS AGREEMENT is made and entered into this 20<sup>th</sup> day of May, 2019, effective as of June 17, 2019, by and between the City of Northglenn, a Colorado home rule municipality (the "City"), and AMANDA BAILHACHE ("Judge Bailhache").

## **RECITALS**

The City Council has determined to appoint Judge Bailhache as the Municipal Judge of the City of Northglenn pursuant to Section 6.11(b) of the City of Northglenn Home Rule Charter and Section 8-1-4(b) of the City of Northglenn Municipal Code, and desires to set the salary of Judge Bailhache pursuant to the above-referenced provisions.

NOW, THEREFORE, it is hereby agreed that, for the consideration hereinafter set forth, the appointment of Judge Bailhache as Municipal Judge of the City of Northglenn shall be made as follows:

#### I. TERM

Judge Bailhache is hereby appointed as the Northglenn Municipal Judge, for an initial term commencing June 17, 2019, through and including January 31, 2021.

#### II. COMPENSATION

Pursuant to Section 6.11(b) of the City of Northglenn Home Rule Charter and Section 8-1-4(b) of the Northglenn Municipal Code, the monthly fixed salary shall be four thousand seven hundred and seventy-seven dollars (\$4,777.00). In addition, the City shall pay the cost of training in an amount not to exceed \$1,000 per calendar year and shall pay the cost of Colorado Supreme Court attorney registration dues in an amount not to exceed \$400 per year.

### **III. OTHER COVENANTS**

Judge Bailhache's job performance, salary and other contractual issues, if any, shall be reviewed by the City Council prior to the date of re-appointment for a new term, or prior to January 31, 2021, and every two (2) years thereafter.

#### IV. COMPLIANCE WITH LAW

Nothing herein shall be deemed to create any additional terms, conditions or obligations of employment in addition to those provided for in the City of Northglenn Home Rule Charter and the City of Northglenn Municipal Code, nor is anything herein intended to change the nature of the Municipal Judge position as an appointed position under the City of Northglenn Home Rule Charter and the City of Northglenn Municipal Code; rather, this Agreement is simply intended to memorialize the term and salary of the Municipal Judge as required by the applicable law.
