Council to order on Monday, December 14, 2020 at 7:00 p.m. Due to the COVID-19 pandemic, the meeting was held remotely with

electronic participation by all members of the City Council.

Council Council member Esquibel reported he attended a Northglenn Senior

Organization meeting and stated he and Mayor Pro Tem Willford will

be hosting a Ward 4 meeting soon.

Council member Duran Mullica reported she attended Noel

Northglenn and stated it was a great event. Council member Duran

Mullica wished everyone a healthy and safe holiday.

Council member Goff reported she is attending the virtual Oregon Housing Conference on COVID and Homelessness during the month of December. Council member Goff reported she spoke with the Edgewater City Council regarding the benefits of joining the Colorado Communities for Climate Action (CC4CA), and reported she also attended a CC4CA legislative meeting. Council member Goff reported she attended meetings of the Diversity, Inclusivity, and Social Equity Board and the virtual Adams County Regional Economic Partnership's legislative breakfast.

Council member Downing reported over 200 bicycles were provided to children at the bike giveaway event at the Stonehocker Farmhouse on December 5, 2020, and thanked Special Events staff and the bike program volunteers their work.

Council member Brown reported she attended Noel Northglenn and commended staff for coordinating the fun event.

Council member Witkovich reported she attended the Historic Preservation Commission meeting on December 8, 2020 and stated the group is making good progress on their strategic plan, mission statement, objectives, and goals.

Council member Peterson reported on the Legislative Policy Committee meeting, which included an update on the 2021 State legislative session beginning on January 13, 2021, the special 2020 legislative session, and a debrief of the December 7 legislative preview meeting. He reported the Committee also discussed Lobbying Day and holding a supplemental meeting with County legislators. Council member Peterson reported the Legislative Issues Guide has been distributed, and stated he enjoyed spending part of the Thanksgiving holiday with members of the Police Department.

Mayor Pro Tem Willford reported she attended a CC4CA Board meeting on December 4, 2020 and thanked Council member Goff for speaking to the Edgewater City Council. She noted the coalition continues to grow as Edgewater and Adams County are planning to join the organization. Mayor Pro Tem Willford reported she attended the Colorado Municipal League Policy Committee meeting and provided information about the bills that were discussed. She introduced Ace, the new puppy her family recently adopted, and wished everyone a Merry Christmas and happy holidays.

Mayor Leighty reported she attended numerous meetings about the COVID-19 vaccine distribution. She wished everyone happy holidays

and stated Northglenn residents have done an outstanding job decorating for the holidays.

Council member Brown noted that an interactive holiday lighting map can be found on NextDoor.

Staff

City Manager Geyer introduced Tamara Dixon, Human Resources Director and Chief Diversity Officer, to City Council. Ms. Dixon provided information about her experience and stated she is excited to be a part of the City of Northglenn.

Rob Webber, Public Works Operations Manager, recognized Doug Pullen, Facilities Maintenance Supervisor, who is retiring after 35 years with the City. Mr. Webber stated Doug's skills and historical knowledge will be missed, and wished Doug the best in retirement.

City Clerk Small provided information about voter turnout in the November 3, 2020 general election, and thanked voters for the extraordinary participation.

City Attorney Hoffmann stated municipalities are considering legislation to cap delivery fees for vendors such as GrubHub and DoorDash and asked Council if they would like to consider similar legislation. There was discussion and it was the consensus of Council to move forward with considering a cap on third-party food delivery fees in the City.

October 2020 Report

Jason Loveland, Director of Finance, provided a financial report for October 2020. Mr. Loveland spoke about revenue and expenditures in the General Fund, Water Fund, Wastewater Fund, Stormwater Fund, Sanitation Fund, Conservation Trust Fund, and Capital Projects Fund. Mr. Loveland also reported on the City's cash reserves through October 31, 2020. Mr. Loveland addressed questions from Council about utility bill payments.

PUBLIC HEARINGS:

CB-1956 – Community Co-Production Policing Advisory Board

City Clerk Small read the title.

Mayor Leighty opened the public hearing on CB-1956 and called for any person wishing to speak either "for" or "against" CB-1956.

An individual spoke about the ex-officio position on the Community Co-Production Policing Board and stated he would prefer that a person of color hold the position to provide the desired representation on the Board.

Mayor Leighty called for any other person wishing to speak on CB-1956. There was no response and the public hearing was closed.

CB-1957 – Retail Tobacco Licensing

City Clerk Small read the title.

Mayor Leighty opened the public hearing on CB-1957 and called for any person wishing to speak either "for" or "against" CB-1957.

Theresa Smith, Tri-County Health Department, spoke in favor of CB-1957. Ms. Smith recommended the ordinance be amended to include a minimum number of local compliance checks, cautioned against providing reduced annual renewal fees as part of a licensing incentive program, and strongly recommended the minor in possession language be removed from the ordinance.

Thomas Briant, Executive Director and legal counsel for the National Association of Tobacco Outlets, provided information about tobacco sales and requested that CB-1957 be amended to explicitly grandfather-in current tobacco businesses. Mr. Briant urged Council to waive first year license fees and recommended the fines and suspensions be reduced.

City Clerk Small read an email from Russ Cowan, 710 Pipes, in favor of CB-1957. Mr. Cowan's email questioned whether current businesses are grandfathered-in and addressed compliance checks and illegal tobacco sales.

City Clerk Small read an email from Grier Bailey, Executive Director of Colorado Wyoming Petroleum Marketers Association and Colorado Convenience Store Association. Mr. Bailey asked Council to delay the public hearing on CB-1957 to allow more input to occur after the state has finished implementing its regulatory framework.

City Clerk Small played a voice mail from Nancy Riggs requesting Council to consider the impact COVID-19 has had on convenience stores when implementing a retail tobacco licensing program by waiving the license fee for the first year and lowering the penalties.

Mayor Leighty called for any other person wishing to speak on CB-1957. There was no response and the public hearing was closed.
