**PURPOSE**

To consider CR-22, a resolution assigning the 2021 Wastewater Treatment Plant: Biosolids Removal, Hauling and Disposal contract to Denali Water Solutions.

**BACKGROUND**

Veris Environmental, LLC is a waste management company located in Limon. The company is under contract with the City for the removal and disposal of biosolids from the Wastewater Treatment Plant.

On Feb. 8, 2021, Veris Environmental, LLC informed the City that it had been acquired by Denali Water Solutions. Due to the acquisition, it is necessary for City Council to assign the existing contract to Denali Water Solutions.

Council originally approved the contract with Veris on Jan. 25, 2021, through Resolution No. 21-10 for the amount of \$300,000.

**BUDGET/TIME IMPLICATIONS**

There are no financial or time impacts to the City.

**STAFF RECOMMENDATION**

Attached to this memorandum is CR-22, a resolution that, if approved, would assign the City's contract with Veris Environmental, LLC to Denali Water Solutions.
