**SUBJECT:** CR-27 – Northglenn Arts & Humanities Foundation Per Capita Funding

#### **PURPOSE**

To consider CR-27, which would approve the release of per capita funds to the Northglenn Arts & Humanities Foundation (NAHF) in the amount of \$77,216.

## **BACKGROUND**

Through Resolution No. 04-107, Series of 2004, the City of Northglenn has supported the intention to fund the NAHF. In 2018, City Council provided direction through Resolution No. 18-25 to increase the formula from \$1 per capita to \$2 per capita.

The NAHF operates as an independent 501(c)3 organization, in collaboration with the Department of Parks, Recreation & Culture, to provide high-quality theatre, concerts, arts education, public art and other performing arts endeavors. The NAHF depends upon grants, donations, fundraising, sponsorships, investment income and the City's per capita contribution to support the programs that are offered through Northglenn Arts, the City's Cultural Programs Division. Funding from the NAHF supports programs including:

- Northglenn Youth Theatre (NYT)
- NYT Academy
- Missoula Children's Theatre
- Summer Concerts
- Summer Movies
- Art on Parade

Through Northglenn Arts Presents, the NAHF has supported productions by a wide variety of local arts entities, including:

- Cleo Parker Robinson Dance
- ImaginASL
- Black Arts Festival
- Northglenn High School

### **UPDATE**

## COVID-19

Beginning March 14, 2020, nearly every Northglenn Arts program was modified or canceled due to the COVID-19 pandemic. Throughout the year, modified versions of NYT, Summer Concerts, Summer Movies, NYT Academy, and public art programs were a positive thread keeping our community together during a difficult time. Staff adapted programs based on guidance from the Tri-County Health Department and the Colorado Department of Public Health and Environment, incorporating virtual rehearsals, socially-distant productions, drive-ins and livestreaming into this year's offerings.

## Strategic Plan

The NAHF believes that partnerships such as the one with the City of Northglenn are a valued community asset. The NAHF has embraced the struggles caused by the pandemic, social unrest, and political upheaval that our community and nation have faced. That, combined with the highly-anticipated opening of the new theatre in late 2021, has been a catalyst to reimagine what the future might hold. As 2020 came to a close, the NAHF re-evaluated its vision and programming goals, resulting in a newly-developed strategic plan. This plan represents the beginning of the next significant chapter in Northglenn Arts' 45-year history; aiming to tell stories that reflect the diversity, inclusivity, and social equity needs and expectations in our community through additional collaborations with metro area organizations funded by the Scientific and Cultural Facilities District (SCFD) from Su Teatro Cultural and Performing Arts Center to Phamaly Theatre Company.

# SCFD Grant Funding

The NAHF is excited to announce that it has been awarded grant funding in the amount of \$95,587.50 by SCFD for 2021, continuing the trend of being a top award recipient in Adams County. The release of the per capita funds, along with the SCFD award and other funding sources, will allow the NAHF to continue providing the ever-evolving and relevant arts programming the community has come to expect.

## **BUDGET/TIME IMPLICATIONS**

The Colorado Department of Local Affairs' most current published estimate of Northglenn's population is 38,608; at a rate of \$2 per capita, this equates to a total expense of \$77,216. Funding is available in the 2021 General Fund.

### STAFF RECOMMENDATION

Staff recommends approval of CR-27.

The NAHF Board of Trustees would accept these funds, and utilize them in a manner consistent with the mission "...to maintain and nurture the cultural arts for the benefit of our community." Also attached to this memorandum is a letter of support from the NAHF Board of Trustees.
