Economic Development Update

Mr. Ryan Stachelski, Economic Development Manager, provided an update on the Economic Development Strategic Plan and the development of a Business Incentive Policy. Mr. Stachelski spoke about upcoming discussions with the Northglenn Urban Renewal Authority (NURA), information that is being prepared for the International Council of Shopping Centers Conference, the Malley Center, and new businesses in the City. Mr. Stachelski provided information about the recent Enterprise Zone meeting, the Economic Development e-newsletter, the enhanced online business directory,

and the sales tax geocode report.

It was stated that Council would like to receive the e-newsletter. There was discussion about the Enterprise Zone meeting and the

value of new businesses in the City.

Mayor Pro Tem Clyne called for any person wishing to address City Council on matters of community interest related to City business not set for public hearing to come forward.

Mr. Ray DeWeese, Ward I, expressed concern about allowing

medical marijuana dispensaries in the City. Mr. DeWeese also spoke about snow and ice removal and stated that more sand is needed at the bottom of inclined streets and at intersections.

Mr. John Kauffman, Principal of Global Village Academy, spoke about the Global Village Academy International Charter School that has been approved by School District 12. Mr. Kauffman provided information about the language immersion environment at the school and stated they are pleased to be located in the City of Northglenn.

Ms. Christina Burton, Executive Principal of Global Village Academy Aurora, spoke about the concept of teaching content through language and introduced a student, Hannah, who spoke to Council in the Chinese language. Ms. Burton spoke about the success of the charter school in Aurora and stated they are excited to be adding a school in Northglenn.

Dr. Sean Reif, Ward I, spoke about the Planning Commission, the importance of planning, and citizen involvement. Dr. Reif also spoke about pedestrian safety along York Street, increasing the availability of services by opening the City Clerk's office on Saturdays, and public meetings.

Northglenn City Council January 13, 2011

City Attorney Hoffmann reported that an ordinance to amend the Sales and Use Tax Code would be drafted for the next regular meeting to reflect the correct sales and use tax rates due to the expiration of the ½% sales tax on food for home consumption. City Attorney Hoffmann also spoke about the status of the ordinances to adopt the international codes.

Mr. David Willet, Public Works and Utilities Director, provided information about snow and ice removal and the Public Works Department's efforts to clear roadways in residential areas.
