**SUBJECT:** City Staff Bandwidth Mid-Year Check-in

### **PURPOSE**

To provide City Council with an update on City staff bandwidth.

#### BACKGROUND

The 2019-2023 Strategic Plan was adopted by Council in October 2019. During the Feb. 27, 2021 retreat, Council was provided with updates on the Strategic Plan and had the opportunity to brainstorm new ideas. Overall, 41 items were considered for prioritization, which included Council new ideas, staff new ideas, and unfunded tactical actions in the current Strategic Plan. Council was asked to identify their top five priorities based on staff bandwidth (current workload to include the City's COVID-19 response and recovery efforts, existing Strategic Plan initiatives and day-to-day operational activities). The City Manager made a commitment to provide Council with an update on staff bandwidth mid-year. Council identified eight items as the highest priority, which are listed below in no particular order. These items will be added to a revised Strategic Plan and brought back to Council for adoption via resolution.

Council prioritized the following items at the Feb. 27 planning session:

- Restorative justice program
- Police Department co-response program
- Village Greens fencing
- Webster Lake safety concerns
- Pedestrian and roadway safety
- N Line fare equity regional initiative
- Boys & Girls Club
- Adventure course targeting ages 12+

On May 17, staff provided Council with an update on progress around these eight priorities.

### **The Ideas List**

Attachment 1 contains the complete list of ideas that Council was asked to prioritize. Highlighted are the eight items that were prioritized. The intention was for the remaining ideas to be revisited during the next annual Council retreat in 2022. However, City Council has requested an opportunity to revisit the list sooner so an updated list is provided in Attachment 2.






