A BILL FOR AN ORDINANCE AMENDING SECTIONS 11-6-11, SUBSECTION (b) AND 11-7-2, SUBSECTION (b) OF THE NORTHGLENN MUNICIPAL CODE REQUIRING THAT TRASH CONTAINERS BE KEPT STORED SO AS NOT TO BE VISIBLE FROM THE PUBLIC RIGHT OF WAY

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 11-6-11, subsection (b) of the Municipal Code of the City of Northglenn, is hereby amended to read as follows:


(b) All trash containers shall be covered, AND EITHER stored within a building or behind the front line of the principal building, AND IF STORED BEHIND THE FRONT LINE OF THE PRINCIPAL BUILDING OR WITHIN THE SETBACK PROVIDED HEREIN, SHALL BE STORED SO AS TO NOT BE VISIBLE FROM THE PUBLIC RIGHT-OF-WAY, and other than as provided in section 11-13-13 shall be set back a minimum of 5 feet from all property lines, except when concealed with an opaque screen, no set back shall be required. Under no circumstances shall such container be placed on a public right-of-way.


Section 2. Section 11-7-2, subsection (b) of the Municipal Code of the City of Northglenn, is hereby amended to read as follows:

- (b) All trash containers shall be:
- (1) Covered;
 - (2) EITHER stored within a building or behind the front line of the principal building AND IF STORED BEHIND THE FRONT LINE OF THE PRINCIPAL BUILDING OR WITHIN THE SETBACK PROVIDED HEREIN, SHALL BE STORED SO AS TO NOT BE VISIBLE FROM THE PUBLIC RIGHT-OF-WAY;
 - (3) Set back a minimum of 5 feet from all property lines, except that when such containers are sealed with an opaque screen, no set back shall be required. Under no circumstances shall any such container be placed on a public sidewalk, street, or right-of-way; AND
 - (4) CONTAINERS ACQUIRED FROM OR OTHERWISE APPROVED BY THE CITY, AND SPECIFICALLY NOT INCLUDING TRASH BAGS OR BOXES OF ANY TYPE.

Section 3. This Ordinance shall become effective in accordance with Section 4.9 of the Charter, but for purposes of the implementation and enforcement of the provisions of this Ordinance, the effective date of this Ordinance shall be August 1, 2007.
