SUBJECT:	Appointment of Deputy Municipal Judges

PURPOSE

To consider CR-74, a resolution appointing three Deputy Municipal Judges of the City of Northglenn.

BACKGROUND

In May 2019, City Council approved Resolution No. 19-56, appointing Kathryn Kurtz as a Deputy Municipal Judge of the City. Recently, Kurtz was appointed Presiding Municipal Judge for the City of Arvada and she is no longer able to serve as a Deputy Municipal Judge for Northglenn.

Judge Amanda Bailhache is recommending that three Deputy Municipal Judges be appointed. Deputy Municipal Judges are usually needed on an emergency or last-minute basis; as such having three available increases the ability to find coverage in an emergency. The following are being recommended; all are experienced Municipal Judges:

- Randall Davis
- Michael Goodbee
- Michelle Kline

Bailhache recommends that Deputy Municipal Judges be compensated on a half-day or full-day basis. This is a more cost-effective way to compensate the Deputy Municipal Judge if their services are not required for a full day. Resolution No. 19-56 specified that compensation for any day in which such Judge's services were required would be \$675, therefore the recommended compensation for a half-day of service is \$337.50 and \$675 for a full day of service.

Since November 2019, the Municipal Court has needed a Deputy Municipal Judge for one and a half days total.

BUDGET/TIME IMPLICATIONS

On days that the Presiding Municipal Judge needs coverage, this would cost the City \$337.50 for a half-day and \$675 for a full day.

STAFF RECOMMENDATION

Staff recommends approval of CR-74.
