SUBJECT: CR-90 - Acceptance of 2021-2022 High Visibility Impaired Driving Enforcement

Grant

PURPOSE

To consider CR-90, a resolution accepting a grant from the High Visibility Impaired Driving Enforcement (HVE) program in the amount of \$10,000 to provide officer overtime for the enforcement of impaired driving laws.

BACKGROUND

The Police Department applied for and was awarded a \$10,000 grant from the Colorado Department of Transportation (CDOT) HVE Program, for officer overtime associated with enforcement of Colorado's impaired driving laws, commonly referred to as DUI holiday enforcement, for the period of July 1, 2021 through June 30, 2022.

BUDGET/TIME IMPLICATIONS

The \$10,000 is the maximum available for the grant this year. The funds would be reimbursed from CDOT following the enforcement period. Based on recent history of officer overtime for DUI holiday enforcement, the Police Department should be reimbursed for the entire \$10,000.

STAFF RECOMMENDATION

Staff recommends approval of CR-90.
