A BILL FOR AN ORDINANCE AMENDING ARTICLE 9 OF CHAPTER 16 REGARDING MEMBERSHIP ON THE NORTHGLENN HISTORIC PRESERVATION COMMISSION

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 16-9-4 of the Northglenn Municipal Code is repealed and reenacted to read as follows:

Section 16-9-4. Historic Preservation Commission Established.

- (a) There is hereby created a Historic Preservation Commission which shall have principal responsibility for matters of historic preservation as set forth in this Article.
- (b) The Commission shall consist of NO LESS THAN seven (7) members, all residents of the City, who shall be appointed by the City Council.
- (c) The members shall serve three (3) year staggered terms from the date of appointment. To stagger the initial terms of membership, the original Commission shall consist of: two (2) members to serve one (1) year terms; two (2) members to serve two (2) year terms; and three (3) members to serve three (3) year terms.
- (d) A member may serve only two (2) consecutive terms. Appointments to fill vacancies shall be made by the City council.
- (ed) All members shall serve without compensation, except for such amounts determined appropriate by the City Council to offset expenses incurred in performance of their duties.
 - (fe) Members may be removed for cause by the City Council.
- (gf) The Commission shall, by majority vote, elect one (1) of its members to serve as chairperson to preside over the meetings, and one (1) member to serve as vice-chairperson. The members so designated shall serve in these capacities for terms of one (1) year, and may serve successive terms.
- (hg) The Commission shall, by majority vote, elect one (1) of its members to serve as secretary. The secretary shall take minutes of each meeting, be responsible for publication and
