SUBJECT: CR-102 2008 Landfill Services Contract

RECOMMENDATION:

Attached to this memorandum is a Resolution which, if approved would authorize the City Manager to issue a Purchase Order to Republic Services of Colorado in an amount not to exceed \$175,000.00.

BACKGROUND:

In 2005, the City of Northglenn entered into a contract with Republic Services of Colorado for landfill services (SR 05-02). This contract allows for five consecutive one year extensions subject to satisfactory performance and annual appropriation of funds. The City has received a letter from Republic stating their desire to renew the contract at the unit price of \$9.83 per ton for calendar year 2008. This price reflects the original amount of \$9.49 per ton plus \$.34 per ton surcharge added by the State on July 1st of this year. \$175,000 will pay for disposal of the approximate 18,000 tons of residential trash collected by the City every year.

POTENTIAL OBJECTION:

City Staff is not aware of any specific opposition to the proposed Resolution.

BUDGET/TIME IMPLICATIONS:

Council's approval of this Resolution will result in a 2008 expenditure of up to \$175,000 for landfill services. This amount has been included in the approved 2008 Sanitation Fund Budget.

The City Manager shall issue a Purchase Order to Republic Services of Colorado in an amount not to exceed \$175,000 for landfill services for calendar year 2008.


