City Manager Krieger provided an overview of the proposed 2008 budget and spoke about the projected revenue and expenditures for the major funds within the budget.

Mr. Lee Brown spoke against the proposed budget and inquired about funding allocated for recreation center operating expenditures. Mr. Brown spoke reports regarding the recreation center and also inquired about land transactions related to the 120th Avenue development project.

Mayor Novak provided information on the projected revenues in the proposed budget and utility expenditures for the 120th Avenue development project. City Manager Krieger spoke about the development agreement and the costs that would be incurred by the City and the Northglenn Urban Renewal Authority (NURA).

Mr. Ervin Baker stated that he feels the budget presented is lavish and spoke against approving the budget.

Mr. Dallas Briggs expressed concern about the few questions asked and input given to the City Manager for the proposed budget. Mr. Briggs spoke about funding for concrete work and personnel expenditures, and also spoke about Council's collective vision for the City.
