Trash Containers

City Clerk Lentz read the title.

Mr. Raymond DeWeese, Ward I, spoke against CB-1615. Mr. DeWeese stated that he feels the existing trash container ordinance is sufficient and feels the City should address other issues.

Mr. Dallas Briggs, Ward I, inquired about areas of the City that would be exempt from the proposed ordinance. Mr. Briggs spoke in favor of CB-1615 and stated that he feels the ordinance would contribute to a clean and beautiful City. Mr. Briggs spoke about the residential and commercial properties that would be affected by CB-1615 and urged Council to adopt the ordinance.
