SUBJECT:

CR-74, Liquor Licensing Fee Increase

RECOMMENDATION:

Attached to this memorandum is a proposed resolution which, if approved, would increase the fees for certain liquor license applications to the new limits allowed by the State. Staff recommends approval of this proposed resolution.

BACKGROUND:

Senate Bill 07-149 was signed into law by Governor Ritter on April 20, 2007. The Bill raises the maximum fee that local licensing authorities may charge for the following license applications: new license applications, transfer of ownership applications, renewal applications and special event permit applications. The new limits are the maximum fees permitted, and the fees charged by the City must be set to cover actual and necessary expenses incurred in processing the applications.

Any fees amended according to the Bill may not take effect until August 8, 2007, which is the Bill's effective date, and may apply only to applications received on or after August 8, 2007.

The Bill allows for a phased-in increase as shown in the table below. If approved, CR-74 would raise the current fees to the maximums allowed in the first phase, which would be effective for the period of August 8, 2007 through July 1, 2008.

Staff prepared an analysis of actual costs for processing the license applications for the Liquor Licensing Authority's review, and at the June 4, 2007 meeting of the Authority, the members unanimously approved a motion to recommend to City Council that the liquor license application fees be raised to the new limits allowed by Senate Bill 07-149.

POTENTIAL OBJECTION:

City Staff is not aware of any specific opposition to the proposed fee increase.

BUDGET/TIME IMPLICATIONS:

The fee increase request would result in additional revenue estimated to be less than \$2,500.00 annually.
