

A BILL FOR A SPECIAL ORDINANCE SETTING THE SALARY OF THE NORTHGLENN MUNICIPAL JUDGE COMMENCING JANUARY 1, 2007.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Commencing January 1, 2007, the Northglenn Municipal Court Judge shall receive the following salary:

- (a) \$4,500.00 per month for five (5) full days and four (4) half day sessions, or less;
- (b) an additional \$642.00 for each additional full day, if such a full day session shall become necessary; and
- (c) an additional \$321.00 for each additional half day, if such a half day session shall become necessary.
