SUBJECT: CR-8 – Edward Byrne Memorial Justice Assistance Grant Acceptance

### PURPOSE

To consider CR-8, a resolution accepting the Edward Byrne Memorial Justice Assistance Grant (JAG) Program grant award in the amount of \$16,173 for computer equipment and training, and crowd control safety equipment.

### BACKGROUND

The JAG Program is the primary provider of Federal criminal justice funding to states and units of local government. The JAG Program allows states and local governments to use grant funds to support a broad range of activities to prevent and control crime based on their own local needs and conditions. These funds can be used to provide personnel, supplies, technical or contractual support, training, or equipment for law enforcement programs that support initiatives such as crime prevention, justice information sharing, reducing crime, or enhancing public/officer safety.

#### **Computer Voice Stress Analysis System**

Over the past 24 months, recruiting has taken on new significance as it has become a critical issue in law enforcement, not only in Northglenn, but across the country. Based on recommendations from the 360 Assessment, the Police Department (NPD) has worked toward enhancing recruiting and hiring efforts to maintain a highly qualified, diverse, and trained workforce.

In reviewing the department's processes, a key area identified for improvement is dependency on external services. NPD's goal is to improve its hiring position by streamlining processes and bringing external services in-house. One identified method is to replace external polygraph examination with Computer Voice Stress Analysis (CVSA). CVSA is a cutting-edge truth verification system that has been established as a vital pre-employment investigative tool. The department would purchase this technology and conduct these examinations in-house. The CVSA system will reduce or eliminate the need to send candidates to a third-party vendor for polygraph examinations and deliver immediate results. Over 30 agencies in Colorado use this system, including the Westminster, Broomfield, and Boulder police departments. Grant funding in the amount of \$9,280 would be used to purchase the CVSA equipment and to train and qualify three NPD members as examiners on the system.

#### **Crowd Control Safety Gear**

Crowd control has become a necessary skill for departments across the country, and officer safety is critical during these operations. Currently, NPD has no safety gear for officers to wear for these CR-8 – Edward Byrne Memorial Justice Assistance Grant Acceptance Jan. 10, 2022 Page 2 of 2

situations. The safety gear is designed to protect officers from rocks, bottles and other projectiles launched at officers during volatile public gatherings. Crowd control safety equipment includes hand-held shields, helmets with face shields, and shin guards. Grant funding in the amount of \$6,916 would allow the department to provide 14 sets of this vital safety equipment for officers to use during emergency crowd control operations.

#### **BUDGET/TIME IMPLICATIONS**

The total cost for all equipment and training is \$16,196. The grant would provide \$16,173 in funding. The Police Department would absorb the \$23 overage into the annual budget.

The equipment would be ordered immediately after approval; arrival, training and implementation would likely take a few months.

### STAFF RECOMMENDATION

Staff recommends approval of CR-8, a resolution that, if approved, would accept the local JAG Program grant award in the amount of \$16,173 to purchase a CVSA computer, train examiners, and purchase crowd control safety gear.

# Memorandum Regarding NEPA

NEPA Letter Type

OJP - Ongoing NEPA Compliance Incorporated into Further Developmental Stages

**NEPA** Letter

The Edward Byrne Memorial Justice Assistance Grant Program (JAG) allows states and local governments to support a broad range of activities to prevent and control crime and to improve the criminal justice system, some of which could have environmental impacts. All recipients of JAG funding must assist BJA in complying with NEPA and other related federal environmental impact analyses requirements in the use of grant funds, whether the funds are used directly by the grantee or by a subgrantee or third party. Accordingly, prior to obligating funds for any of the specified activities, the grantee must first determine if any of the specified activities will be funded by the grant.

The specified activities requiring environmental analysis are:

a. New construction;

b. Any renovation or remodeling of a property located in an environmentally or historically sensitive area, including properties located within a 100-year flood plain, a wetland, or habitat for endangered species, or a property listed on or eligible for listing on the National Register of Historic Places;

c. A renovation, lease, or any proposed use of a building or facility that will either (a) result in a change in its basic prior use or (b) significantly change its size;

d. Implementation of a new program involving the use of chemicals other than chemicals that are (a) purchased as an incidental component of a funded activity and (b) traditionally used, for example, in office, household, recreational, or education environments; and

e. Implementation of a program relating to clandestine methamphetamine laboratory operations, including the identification, seizure, or closure of clandestine methamphetamine laboratories.

Complying with NEPA may require the preparation of an Environmental Assessment and/or an Environmental Impact Statement, as directed by BJA. Further, for programs relating to methamphetamine laboratory operations, the preparation of a detailed Mitigation Plan will be required.
