Council to order on Monday, December 6, 2021 at 6:00 p.m. in the City Hall Council Chambers, 11701 Community Center Drive,

City Clerk Small played an audio recording of comments submitted by Mark Bromley. Mr. Bromley spoke about Pride event signage at E.B. Rains, Jr. Memorial Park, the 2021 Election, homelessness, the

use of the former recreation center as a temporary homeless shelter,

and COVID-19 related mandates.

Council member Brown asked City Manager Geyer about Pride event signage at E.B. Rains, Jr. Memorial Park. Manager Geyer stated the

stencils painted onto the sidewalk on the west side of the park were

intended to be temporary and will wear off. Council member Brown suggested staff use chalk for the stencils in the future.

Desiree Moralez, 9688 Lou Dr., spoke in favor of using the former recreation center as a shelter for people experiencing homelessness and offered her support once the program is implemented.

Council member Brown stated she enjoyed Noel Northglenn and thanked staff for the fantastic event.

Council member Duran Mullica attended a joint Regional Transportation District (RTD) and Colorado Department of Transportation (CDOT) sponsored bus tour in November intended to address traffic safety concerns on the I-25 corridor between 84th Avenue and the 88th Avenue RTD Park-N-Ride; discussions will be on-going regarding solutions for the area.

Council member Lukeman-Hiromasa attended a special meeting of the Community Co-Production Policing Advisory Board (CCPP) regarding their partnership with The Equity Project; another joint meeting will take place in January. Member Lukeman-Hiromasa stated she took a tour of the Colorado Safe Parking Initiative program at Arvada Covenant Church and it was an informative experience. She also attended a community meeting regarding the usage of the former Northglenn recreation center as a temporary shelter for those experiencing homelessness; a lot of community support for the program was expressed. Lukeman-Hiromasa stated she also attended Noel Northglenn and it was a fun event.

Mayor Pro Tem Willford spoke about the Colorado Safe Parking Initiative program tour at Arvada Covenant Church, stating it was a really good experience. Mayor Pro Tem Willford provided updates on the Colorado Communities for Climate Action (CC4CA) Board and the Colorado Municipal League Policy Committee meetings she recently attended. Lastly, Mayor Pro Tem Willford thanked staff for organizing the community meeting regarding the usage of the former recreation center as a temporary homelessness shelter. The meeting had great attendance and a lot of community feedback was received regarding the proposed program.

Mayor Leighty stated she attended Noel Northglenn and thanked staff and Council for participating in the great event. Mayor Leighty reported on the Adams County Council of Governments (ADCOG) meeting she recently attended and stated she also attended the Northglenn community meeting regarding the usage of the former recreation center as a temporary shelter. The community meeting was well attended, there were thoughtful questions posed, and a lot of helpful feedback was given. Mayor Leighty reported the Northglenn

Bike Program gave away over 300 bicycles on December 4th at a great giveaway event and she also attended the Northglenn American Legion Post #22's Christmas celebration.
