SUBJECT:	CR-48 – Marshall Fire Relief Fund Donation

PURPOSE

To consider CR-48, a resolution approving a \$5,000 donation to the Boulder County Wildfire Fund to assist those impacted by the Marshall Fire.

BACKGROUND

During the Jan. 24 regular meeting, Council directed City Manager Heather Geyer to provide Council with a recommended donation amount for the Marshall Fire relief efforts and a consensus was achieved by Council for \$5,000. Funding will assist residents of impacted cities and towns to include: Town of Superior, City of Louisville, City and County of Broomfield, and Boulder County.

City Support

During the night of the fires on Dec. 30, 2021, 12 Northglenn Police Department officers assisted local authorities in their response efforts. Six stayed until 5:30 a.m. to prevent looting and to keep individuals out of dangerous areas. On Dec. 31, five officers provided assistance in Superior.

Eight Victim Advocates and numerous volunteers worked from 6 until 10:30 p.m. at the 1st Bank Center on Dec. 30 to help those who needed shelter. They assisted about 50 evacuees with locating shelter, Lyft rides, phone chargers, blankets, hats, snacks, and items for kids like stuffed animals and coloring books. They coordinated with shelters throughout the region, including Crossroads Church in Northglenn and two hotels in the area. In addition, they proactively contacted pet stores and received donations for pet food, beds, treats and other needed items.

The City's Water and Wastewater divisions and Parks, Recreation, & Culture Department were on stand-by to provide staff coverage and emergency shelters, but it was not necessary.

Mayor and City Manager Gift Baskets

Mayor Meredith Leighty and Geyer provided a gift basket of goodies in support of their fellow mayors and city managers. The baskets included the following items:

- Cookies from Cakes by Karen
- Snacks from Mountain Man
- Food item from Beltran's Meat Market
- Chocolate box from M² Confections
- Northglenn coffee mug, socks, playing cards, carabiner, and hacky sack ball

WHEREAS, on December 30, 2021, the Marshall Fire burned more than 6,000 acres and destroyed nearly 1,100 homes and structures in Boulder County;

WHEREAS, the City Council desires to provide a monetary donation to assist residents in the City of Louisville, Town of Superior, City and County of Broomfield, and Boulder County who were impacted by the fire; and

WHEREAS, Section 8.10 of the City of Northglenn Home Rule Charter allows for the use of City Council contingency funds for unforeseen expenditures with the express approval of the Council.
