# PURPOSE

To consider CR-55, a resolution to name the site currently referenced as "Justice Center West Park" after former Mayor Odell Barry.

#### BACKGROUND

A proposal to name the future park site at 421 W. 112<sup>th</sup> Ave. after former Mayor Odell Barry was submitted by the Diversity, Inclusivity and Social Equity Board (DISEB) in May 2021. The proposal was presented during a regular meeting of the Parks and Recreation Advisory Board (PRAB) on June 10, 2021. Per the City's policy for naming and renaming parks and recreation facilities, the PRAB heard the proposal and elicited community feedback during the 90-day waiting period. At the conclusion of that waiting period, the PRAB found former Mayor Barry's contributions to the community to be both "extensive and substantial." A partial list of his contributions that were provided as support for the naming request included:

- Became recreation superintendent in 1966 for the Northglenn Metropolitan Recreation District after retiring from the Denver Broncos
- Advocated for the first Northglenn Recreation Center
- Ran a youth football camp for the Northglenn Recreation Center where he coached over 7,000 kids
- Former Chairman of the Colorado Black Chamber of Commerce
- Member of the Colorado Municipal League (CML) Executive Board; successfully advocated to bring the CML conference to Northglenn
- Served on the Northglenn Centennial-Bicentennial project committee
- Served as a member of City Council from 1972 to 1980
- Served as Mayor from 1980 to 1982
- Founding member of the Rotary Club of Northglenn-Thornton

Taking into consideration the original proposal, the public comments that were submitted and Barry's contributions to the City, the PRAB made a unanimous recommendation to name the park "Odell Barry Park" at their regular meeting on Sept. 9, 2021.

During the City Council study session on Feb. 7, 2022, staff and DISEB members provided an overview of the park naming policy, plans for future development of the park site, and Odell Barry's accomplishments. During that meeting, City Council provided consensus to move forward with the recommendation to name the site "Odell Barry Park."

#### **BUDGET/TIME IMPLICATIONS**

There are no financial or time impacts to the City associated with the naming of the park.

A RESOLUTION TO AMEND RESOLUTION 86-70, SERIES OF 1986, ESTABLISHING COUNCIL POLICY FOR NAMING AND RENAMING PARKS AND RECREATION FACILITIES

WHEREAS, the Northglenn Parks and Recreation Advisory Board has made a recommendation that the City Council amend the policy for the naming and renaming of parks and park facilities in the City of Northglenn; and

WHEREAS, the City Council concurs that guidelines and policies of the City Council should be set forth by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

The guidelines for naming and renaming parks and park facilities in the City of Northglenn shall be as follows:

1. Any interested organization, group of citizens, City Board or Commission shall submit a written proposal for naming/renaming a park, garden dedication, memorial or park facility to the Parks and Recreation Board. The Parks and Recreation Board shall be responsible for initial evaluation of the proposal and subsequently make a recommendation to City Council.

2. There shall be a ninety (90) day evaluation period from the date of written submission at a regularly scheduled Parks and Recreation meeting before the Board can make its recommendation to City Council.

3. Alternatives to naming or renaming a park or recreation facility should be considered by the Parks and Recreation Board.

4. The Parks and Recreation Board has the authority to recommend to City Council the naming or dedication of a garden, memorial, etc. within a park.

5. Only parks or facilities named for geographic location, outstanding feature or subdivision should be considered for renaming. Parks or facilities named after individuals shall never be changed unless it is found that because of the individual's character, the continued use of their name would not be in the best interest of the community. No park named for a geographic location, outstanding feature or subdivision should be renamed for a period of ten years.

6. Contribution, whether years of service, monetary donation or significant contribution to the community, should be extensive and substantial.

7. Consideration of agreements with school districts and neighboring entities shall be considered.

8. The Council shall finally, pass a resolution to effect the requested naming, renaming or dedication in order to make the action official.

Dear City of Northglenn Parks and Recreation Advisory Board,

The <u>City of Northglenn City Council 2019-2023 Strategic Plan</u> outlines the city's vision to have Northglenn be a diverse and welcoming community that celebrates its small town character, urban energy, and thriving businesses. One of the primary values of the city of Northglenn is inclusivity and of the strategic goals is maintaining and celebrating our diverse community.

The city of Northglenn yielded a <u>Diversity, Social Inclusivity, and Equity (DISE) Board</u> to use community feedback to influence future decision making that promotes diversity, inclusivity, and social equity in Northglenn.

The City of Northglenn DISE Board would like to propose a recommendation to name the Northglenn Justice Center Park West after former Northglenn Mayor, Odell Barry. Odell was a <u>Denver Bronco</u> <u>wide-receiver player</u> from 1964 to 1965 and coached more than 7,000 kids, served on Northglenn City Council Ward II from 1970 to 1980, elected the first black mayor of Northglenn from 1980 to 1982, and served as the first black elected vice chair of the Colorado Delegation to the National Democratic Convention in 1980.

Furthermore, Barry was the first black man to be a charter member of the Rotary International, and first black president of the Colorado Civil Defense Association. He was a community member, politician, businessman, and passionate about social justice and equal rights. Barry's contributions to Northglenn and the state of Colorado earned him recognition into the <u>Colorado Black Hall of Fame</u>.



On <u>April 4th of 2008</u>, the City of Northglenn made a proclamation and recognized this day as Odell Barry Day. As noted in the proclamation, Odell scored modern, state-of-the-art recreational facilities for the city, and was a cheerleader for the city of Northglenn for decades. <u>On March 25th 2019</u>, Barry was honored as a recipient of the city's Resident Recognition 50th Anniversary Program. He made an impact in the city of Northglenn and advanced the city's strategic goal of diversity.

We believe accepting our recommendation will make a profound statement to the community that we continue to honor his work and want his legacy and name to be visibly seen and known for generations to come. We hope that you will consider this recommendation at your upcoming meeting for review. If you have any questions, please feel free to reach out to us.

Amanda explained the approval process for the naming of parks. This process includes a 90-day waiting period prior to the proposal moving forward to City Council for approval. She also stated that the current name for this park, Justice Center West, is a working name and there is not any current funding identified for the further development of this space.

Sarah Woodson reviewed the basic principles of the DISE Board and requested that the current Justice Center West park be named in honor of Odell Barry who previously served as mayor of Northglenn. She discussed his dedication and service to the city and stated that this honoring would provide a legacy for the family as well.

The Parks and Recreation Advisory Board noted the positive impacts that Mr. Barry had in Northglenn and, to follow policy, will include this proposal as an agenda item for the next 90 days to elicit community feedback. Suggestions were made to reach out to the community via social and printed media.

Sarah inquired about potential funding and Amanda explained that a recent congressionally directed funding application has been submitted. She will update the board as more information becomes available.

#### 6g. Election of Officers

Term limits were reviewed. Andy Hall nominated Paul Weinrauch as President, Karen Kuepfer as Vice-President, and Mary Mondragon as Secretary. These were unanimously approved.

REPORT FROM COUNCIL EX-OFFICIO Ashley Witkovich thanked David Swayze for his service to the Parks and Recreation Advisory Board as he is resigning from the board.

The Ward IV vacancy has been filled by Shannon Lukeman-Hiromasa.

Considerations are made regarding the cost to provide services and determination of a public versus a private benefit.

Upon review of the document, Mary Mondragon made a motion to accept the user fees as recommended by staff and to move forward to City Council. This was seconded by Andy Hall and approved unanimously.

#### 6f. Recreation Programming Usage

Amanda formally introduced Justin Purdue to the board. He provided a brief professional background prior to coming to the City of Northglenn. Justin shared that there has been a rebound in usage throughout the summer with significant increases in sports programs. He reviewed a general overall increase in all areas of recreation when compared to the previous winter participation numbers.

#### 6g. Vending Permit Dates

Initially, parks vending permits in 2021 had an expiration date of September 30. 2021 to allow for review of COVID status. Mary Mondragon made a motion to extend the permit expiration to March 2022. This was seconded by Rob Konrade and unanimously approved.

6h. Gender Neutral Language

City Council and the City Attorney are working on reviewing the municipal code with regards to gender neutral language.

REPORT FROM COUNCIL EX- OFFICIO	Ashley Witkovich stated that council member Randall Peterson has resigned and there is now a vacancy for Ward I. Mingle with the Mayor will resume on September 25.
	Ashley also noted that council member Shannon Lukeman-Hiromasa had asked for clarification about pinata restrictions on city park signs. Amanda explained that many local municipalities have restrictions on items such as pinatas, balloons, and confetti type products as they are difficult to clean up from the park spaces. This sign language will be revisited after review of other communities' verbiage on similar restrictions.
REPORT FROM DIRECTOR	The new facility is substantially complete, and efforts are underway for the upcoming Grand Opening. On October 6, an invitation-only ceremony will take place followed by Friends and Family events on October 7 and 8. The public is invited to the celebration on October 9 which will feature free facility use, music, food vendors, giveaways, and a firework finale. The new facility will open for daily operations on October 10.
