| Black History Month | Mayor Leighty read the proclamation proclaiming February 2022 as Black History Month in the City of Northglenn. Diversity, Inclusivity, and Social Equity Board member Deja Moore accepted the proclamation on behalf of the Board. |

| COMMUNICATIONS: Council | Council member Witkovich reported she attended her first meeting of the Rocky Flats Stewardship Council on February 7 along with staff |

member Shelley Stanley, who serves as an alternate member. She reported the Department of Energy presented quarterly information on the status of the Rocky Flats site and noted she will be taking a tour of the Woman Creek Reservoir area. Council member Witkovich reported she attended the Historic Preservation Commission meeting on February 9 where the Commission reviewed their strategic plan and recommended the inclusion of historic items in the new city hall building to include an old door and the former Garland Center sign. She reported she attended the Parks and Recreation Advisory Board meeting on February 10, which included the annual public hearing on recreation programs. She reported the Board received a donation request from Rupa Venkatesh, Assistant to the City Manager, on behalf of the Denver North Islamic Center for 20 recreation center passes for individuals in the Afghan refugee program, which was unanimously approved by the Board.

Council member Jaramillo reported the Northglenn Arts & Humanities Foundation will host an Art on Parade Committee meeting on February 15 at 5:30 p.m. in the Parsons Theatre and stated anyone interested in joining the selection committee for sculptures should contact Michael Stricker. Council member Jaramillo announced the Cleo Parker Robinson ensemble will be performing at the Parsons Theatre in honor of Black History Month and encouraged everyone to attend the various performances offered at the Theatre.

Council member Goff thanked Mayor Leighty and staff for the Council teambuilding session on February 5. Council member Goff reported she attended the Economic Development workshop on February 10 and the Colorado Communities for Climate Action (CC4CA) policy meeting. She reported CC4CA is working on strategies for three- to five-year goals and 2022 events. Council member Goff reported she attended the Diversity, Inclusivity, and Social Equity Board officer meeting to plan for next week's regular Board meeting.

Council member Duran Mullica spoke about a request from the Regional Transportation District (RTD) for a letter of response for feedback regarding a system optimization plan with a deadline of March 9, 2022. City Manager Geyer received consensus from Council to respond to RTD with feedback. Council member Duran Mullica reported the I-25 and 84th subgroup met last Friday and is focused on fixing safety issues in that traffic area. She reported the Denver Regional Council of Governments (DRCOG) Nominating Committee chose her to serve as one of the representatives on the Front Range Passenger Rail District Board. Council member Duran Mullica reported she received a resident inquiry regarding the Tri-County Health Department and clarified that the Adams County Board of Commissioners can answer questions pertaining to operations within the Health Department. Council member Duran

Mullica announced a Ward 3 meeting will be held on March 2 at 6:00 p.m. at the Justice Center and noted public safety will be the focus.

Council member Lukeman-Hiromasa reported she attended the Youth Commission meeting on February 1 and stated the youth members were amazing. She thanked staff for the Council retreat and stated she is looking forward to the next meeting. Council member Lukeman-Hiromasa reported she attended the Community Co-Production Policing Advisory Board meeting on February 8 and noted Monica Williams from The Equity Project led a discussion on communication and purpose. On February 9, she attended the Business Retention and Expansion Committee meeting and noted she looks forward to being a part of the group as a business owner and to support other small businesses.

Council member Lukeman-Hiromasa reported on the Legislative Policy Committee meeting and stated the group discussed the following bills: SB22-120 – Regulation of Kratom Processors; HB22-1138 – Reduce Employee Single-occupancy Vehicle Trips; HB22-1152 – Prohibit Employer Adverse Action Marijuana Use; HB22-1196 – Pay Equity Study; and HB22-1159 – Waste Diversion and Circular Economy Development Center.

Mayor Pro Tem Willford announced the Ward 4 meeting schedule for 2022: March 31, at Northglenn Recreation Center; May 17; August 25 at Danahy Park; and November 19. Mayor Pro Tem Willford announced she will be absent from the special meeting on February 16. Mayor Pro Tem Willford thanked Mayor Leighty and staff for the recent Council retreat and stated she is excited about the direction in which things are headed.

Mayor Leighty stated she was thankful for a good Council retreat and noted she left energized and excited. Mayor Leighty reported she attended the Metro Mayors Caucus retreat, and she will continue to serve on the executive committee as well as the circle committee, which focuses on sustainability. Mayor Leighty reported she was invited to be a guest speaker on the Ramos Law Difference Makers podcast and stated she was excited to be a part of it. Mayor Leighty invited residents to reach out to Council with questions or concerns if they hear anything they are curious about during public comment at Council meetings and stated she does not want residents to be misled by inaccurate information.

City Clerk Small reported that residents may vote on the "I Voted" sticker submissions by using links on the Adams County Clerk and Recorder's Facebook or Twitter page and noted voting closes on February 17.
