SUBJECT: CR-58 – 2022 Janitorial Services Addendum

PURPOSE

To consider CR-58, a resolution approving a contract addendum with Expert Contract Maintenance for 2022 janitorial services.

BACKGROUND

The 2022 Janitorial Services contract provides custodial services for the Water Treatment Facility, Wastewater Treatment Plant, Maintenance and Operations Facility, and the Northglenn Recreation Center. On Jan. 10, 2022, the City signed a contract with Expert Contract Maintenance to provide janitorial services for the 2022 calendar year. Staff wishes to amend the contract to include custodial services for the Justice Center. Expert Contract Maintenance is proposing to provide custodial services for the Justice Center at a rate of \$2,700 per month through the end of 2022 for a total of \$27,000.

BUDGET/TIME IMPLICATIONS

This contract addendum is for the 2022 calendar year only. Funding is available in the General Fund.

Staff continues to assess the custodial needs for City facilities to determine the cost benefit analysis of centralizing custodial services and shifting our approach based on existing FTEs and contract services. This work will be integrated into the 2023 City Budget.

STAFF RECOMMENDATION

Attached is CR-58, a resolution that, if approved, would authorize the Mayor to execute a contract addendum between the City and Expert Contract Maintenance for 2022 Janitorial Services in an amount not to exceed \$27,000. Staff recommends approval of CR-58.

- B. The parties desire to supplement the Agreement with this Addendum #1 to allow for an additional scope of services to include the Justice Center facility.

AGREEMENT

NOW, THEREFORE, it is hereby agreed that for the consideration hereinafter set forth, that Contractor shall provide to the City, professional cleaning services as needed in the manner provided in the Agreement.

- 1. The Scope of Services in the Agreement is hereby supplemented to include the scope of services for professional attached hereto as **Exhibit A**, and incorporated herein by this reference (the "Additional Scope of Services"). Contractor shall commence work on the Additional Scope of Services within ten (10) days of the issuance of a Notice to Proceed.
- 2. Subparagraph A. of Article IV entitled "Compensation" is hereby amended to provide as follows:
- A. Compensation shall not exceed twenty-seven thousand dollars (\$27,000) for the additional work described in **Exhibit B** to this Addendum # 1.
- 3. The original Agreement is in full force and effect and is hereby ratified by the City and the Contractor. The original Agreement and this Addendum constitute all of the agreements between the City and the Contractor.
