SUBJECT: CR-154 – Edward Byrne Memorial Justice Assistance Grant Acceptance

#### **PURPOSE**

To consider CR-154, a resolution accepting the Edward Byrne Memorial Justice Assistance Grant (JAG) Program grant award of \$17,514 for new patrol bicycles, safety equipment, and Tableau data software.

#### **BACKGROUND**

The JAG Program is the primary provider of Federal criminal justice funding to states and units of local government. The JAG Program provides grant funding to states and local governments for a broad range of activities to prevent and control crime based on their needs and conditions. These funds can be used for personnel, supplies, technical or contractual support, training, or equipment for law enforcement programs that support initiatives such as crime prevention, justice information sharing, reducing crime, or enhancing public/officer safety.

#### **Bicycles and Safety Equipment**

Northglenn is 6.5 square miles and connected internally by a system of sidewalks and paths. Northglenn Police Department (NPD) Officers can travel from one side of Northglenn to the other on a bicycle using these paths. Bikes allow officers to patrol areas more easily than in a vehicle and enhance the type and frequency of patrol in these areas, bolstering community trust and safety.

The bicycles are also invaluable for special events. Between May and December, the City hosts a minimum of 20 moderate to large gatherings at parks or the Civic Center. The bikes allow officers to respond to incidents at the events quickly. This is especially important for the larger events at E.B. Rains Jr. Memorial Park, which spans 28 acres with numerous features that can make it difficult for a vehicle to navigate. Plus, the bikes allow officers to interact with the community more easily than if they were in a vehicle. Overall, the bikes improve direct community engagement and public safety, as well as the trust and legitimacy of NPD.

Replacing the current gear, which is over 10 years old, would revitalize the program along with making it safer for participating officers. The cost for the new bicycles and associated safety equipment is \$13,206.

# **Tableau Data Software**

In January 2020, the City began working with BerryDunn, McNeil, and Parker, LLC, to conduct an Operational Assessment of NPD. This process included input from different stakeholders and

looked at all aspects of the department through the lens of industry best practices. One of the recommendations the NPD leadership team elevated was to "adopt a data-driven philosophy supported by intelligence-led policing (ILP). The philosophy should incorporate best practices in data used by police agencies and should include an operating performance measurement and accountability management system."

By utilizing the total data value, NPD anticipates improved decision-making, more efficient operations, and a positive community impact. To implement the recommendation, NPD recently hired a crime analyst. The second component was to evaluate and implement technology/software for interactive data visualization. NPD has researched various systems and found that Tableau Cloud would best suit its needs. The total cost for the first-year subscription to the Tableau software is \$4,308.

### **BUDGET/TIME IMPLICATIONS**

The total cost for all equipment and software is \$17,514, and the grant would provide \$17,514 in funding. Therefore, there would be no extra-budgetary implications for the City. Training would take several months before the implementation of the software. New bicycles and safety equipment would be purchased as soon as grant funds are received.

#### STAFF RECOMMENDATION

Staff recommends approval of CR-154, a resolution that, if approved, would accept the local JAG Program \$17,514 grant award to purchase bicycles, safety equipment, and Tableau data software.

### Office for Civil Rights Notice for All Recipients

#### **NEPA** Letter

The Edward Byrne Memorial Justice Assistance Grant Program (JAG) allows states and local governments to support a broad range of activities to prevent and control crime and to improve the criminal justice system, some of which could have environmental impacts. All recipients of JAG funding must assist BJA in complying with NEPA and other related federal environmental impact analyses requirements in the use of grant funds, whether the funds are used directly by the grantee or by a subgrantee or third party. Accordingly, prior to obligating funds for any of the specified activities, the grantee must first determine if any of the specified activities will be funded by the grant.

The specified activities requiring environmental analysis are:

- a. New construction;
- b. Any renovation or remodeling of a property located in an environmentally or historically sensitive area, including properties located within a 100-year flood plain, a wetland, or habitat for endangered species, or a property listed on or eligible for listing on the National Register of Historic Places;
- c. A renovation, lease, or any proposed use of a building or facility that will either (a) result in a change in its basic prior use or (b) significantly change its size;
- d. Implementation of a new program involving the use of chemicals other than chemicals that are (a) purchased as an incidental component of a funded activity and (b) traditionally used, for example, in

> office, household, recreational, or education environments; and e. Implementation of a program relating to clandestine methamphetamine laboratory operations, including the identification, seizure, or closure of clandestine methamphetamine laboratories.

Complying with NEPA may require the preparation of an Environmental Assessment and/or an Environmental Impact Statement, as directed by BJA. Further, for programs relating to methamphetamine laboratory operations, the preparation of a detailed Mitigation Plan will be required.
