SUBJECT:	CB-1893 – Marijuana Business Hours

### **PURPOSE:**

To amend Sections 18-14-20 and 18-16-22 of the Northglenn Municipal Code by revising the hours of operation allowed for medical and retail marijuana businesses.

### **BACKGROUND:**

City Council has received communications from representatives of marijuana businesses located in Northglenn regarding extending the hours of operation for marijuana businesses. At the June 26, 2017 regular City Council meeting, staff presented information about the current operating hours allowed and other municipalities' operating hours. Representatives from four marijuana businesses were present and provided public comment about extending the operating hours. Council discussed the request and directed staff to prepare an ordinance for consideration to revise the hours of operation for marijuana businesses.

#### SUMMARY:

The State of Colorado Medical and Retail Marijuana Rules establish hours of operation for marijuana businesses between 8:00 a.m. and 12:00 a.m. seven days a week. CB-1893 proposes to amend two sections of the Northglenn Municipal Code specific to hours of operation for medical and retail marijuana businesses to allow such businesses to open one hour earlier and to close two hours later each day. Marijuana businesses are not required to extend their current operating hours to conform to the proposed ordinance.

18-16-22	A retail marijuana business may open no earlier than 9:00 a.m. and shall close no later than 8:00 p.m. the same day.	A retail marijuana business may open no earlier than 8:00 a.m. and shall close no later than 10:00 p.m. the same day.

A BILL FOR AN ORDINANCE AMENDING ARTICLE 14 AND ARTICLE 16 OF CHAPTER 18 OF THE NORTHGLENN MUNICIPAL CODE CONCERNING THE AUTHORIZED HOURS OF OPERATION FOR MARIJUANA BUSINESSES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 18-14-20 of the Northglenn Municipal Code is hereby amended to read as follows:

**Section 18-14-20.** <u>Hours of operation.</u> A medical marijuana business may open no earlier than 9:00 8:00 a.m. and shall close no later than 8:00 10:00 p.m. the same day. A medical marijuana business may be open seven (7) days a week.

Section 2. Section 18-16-22 of the Northglenn Municipal Code is hereby amended to read as follows:

Section 18-16-22. <u>Hours of operation</u>. A retail marijuana business may open no earlier than 9:00 8:00 a.m. and shall close no later than 8:00 10:00 p.m. the same day. A retail marijuana business may be open seven (7) days a week.
