SUBJECT: CB-1996 – Water and Wastewater Rates

PURPOSE

To consider CB-1996, an ordinance on second reading to increase water and wastewater rates.

BACKGROUND

The City provides water and wastewater utility services to approximately 10,250 customer accounts. The services are funded through water and wastewater charges collected from utility customers. To ensure that future water and wastewater charges would meet the future costs of providing such services, the City contracted with Stantec Consulting in 2017 to complete a water and wastewater rate study. The study results were presented on April 17, 2017. Additional discussions of the proposed rate changes occurred on May 15 and Aug. 7, 2017.

The study determined that to meet the funding and service requirements of water and wastewater operations, revenue collections would need to increase approximately 3.6% to 6.7% annually in each of the subsequent 10 years beginning in 2018. In 2018, the first five years of the 10-year rate increase recommendations were implemented through Ordinance No. 1745 to fund over \$85 million in projects.

UPDATE

After five years, the data from the rate study completed by Stantec Consulting in April 2017 was verified to be sufficient for the second half of the rate study implementation. Increases to water and wastewater revenue collections by 3.6% over the next five years are needed to support significant capital investments to the water and wastewater treatment plants.

Listed below are future capital improvement projects, and their estimated costs, needed at the plants to address regulatory, operational, and capacity requirements:

- 2025 to 2027
 - Lift Station B replacement \$7M
 - Primary clarifier and digesters \$30M
- 2028 to 2031
 - Aeration basins, secondary clarifiers \$37M

These projects, along with future water rights acquisitions, general maintenance projects, and maintaining adequate operating and capital reserves, are the drivers for the rate increase.

The monthly bill to the average residential customer would change as shown below:

Average Consumption	2022	2023	Change per month
Winter 5,000 gallons	\$66.76	\$69.09	\$2.33

The proposed ordinance sets forth rate increases for the next five years as identified in the study. New rates would go into effect each Jan. 1 from 2023 to 2027. Increases beyond 2023 are subject to change if consumption or capital construction costs change meaningfully.

BUDGET/TIME IMPLICATIONS

The 2017 rate study was completed with the intent to minimize significant rate increases in any single year over the period studied. This means consistent, smaller increases over the decade would allow the City to avoid double-digit percentage increases in any one period. Using this approach avoids shocking the ratepayers, which staff and City Council value.

Using the compounding effect strategy would allow the water and wastewater utilities to be well-positioned to finance the regulatory and maintenance requirements to operate over the next several years.

Delaying, or reducing, the proposed rate increases would reduce the effectiveness of the compounding strategy and lead to larger annual percentage increases in the future.

RECOMMENDATION:

Staff recommends approval of CB-1996 on second reading.
