**SUBJECT:** CR-168 – Liquor Licensing Fee Schedule

#### **PURPOSE**

To consider CR-168, a resolution adopting a new schedule of fees for liquor licensing, as permitted by State law.

## **BACKGROUND**

CB-1997, scheduled for public hearing and second reading on Nov. 28, 2022, would amend Section 18-2-3 of the Municipal Code to maintain compliance with the Colorado Liquor Code in relation to House Bill 22-1415 ("HB-1415"), reporting of managers for liquor licensed establishments. Specific to fees, HB-1415 reduces the fees which may be collected by local and State liquor licensing authorities for manager change reporting from \$75 to \$30. That reduction is reflected in CR-168.

In addition, CR-168 implements a fee for takeout and delivery permits, which were authorized by Council with the adoption of Ordinance 1809, Series of 2020. The permit fee shall be set by resolution and shall not exceed the fee for a State takeout and delivery permit, which is currently \$11. State and local takeout and delivery permits will replace the temporary COVID-19 related allowance for to-go beverages to be offered by establishments licensed to sell and serve alcohol for consumption on the licensed premises. Governor Polis recently extended the temporary allowance to the year 2025. Staff anticipates an influx of applications in advance of that expiration date; therefore, implementation of a takeout and delivery permit fee is timely.

All other liquor licensing fees are proposed to remain the same. The new fee schedule includes a complete list of liquor licensing fees.

## **BUDGET/TIME IMPLICATIONS**

Due to the elimination of local authority review, staff time related to processing manager changes would be reduced and the fee reduction from \$75 to \$30 is appropriate.

The takeout and delivery permit fee of \$11 would offset the actual cost incurred by the City for associated administrative processing, supplies, and postage.

## STAFF RECOMMENDATION

Staff recommends approval of CR-168.
