CALL TO ORDER Mayor Leighty called a regular meeting of the Northglenn City

Council to order on Monday, November 14, 2022 at 6:00 p.m. in City

Hall Council Chambers.

Chase spoke about the importance of continued awareness, education, and love, and honored the transgender women

of color who fought for the trans community.

PRESENTATIONS:

Diversity, Inclusivity, and Social Equity Board Update

Diversity, Inclusivity, and Social Equity Board members Tina Fischel, Chase Janis, and Autumn Romero presented an update on the Board's activities to Council. The update included information on the Board's learning, diversity, equity, and inclusion survey, accomplishments, recommendations, and plans for 2023.

There was discussion about an opportunity for the Board to partner with the Northglenn Urban Renewal Authority regarding inclusive businesses, the Board's annual budget, and the possibility of holding a Pride event in Northglenn next year.

PUBLIC INVITED TO BE HEARD

Mayor Leighty called for any person wishing to address City Council on matters of community interest related to City business not set for public hearing.

Chris Baum, 11176 Livingston Drive, expressed concern about the Transgender Awareness Month proclamation.

COMMUNICATIONS:

Council

Council member Walker provided an update on the Legislative Policy Committee meeting. He shared information about two ballot measures that passed regarding the Income Tax Reduction Act and Proposition 123.

Council member Walker reported on the North Area Transportation Alliance (NATA) meeting. He stated Smart Commute is requesting financial assistance from Northglenn in the amount of \$1,214 for the Wagon Road and 144th Avenue FlexRide program. He stated the amount is based on the number of Northglenn residents who use FlexRide and asked if the financial request could be considered at the November 28, 2022 Council meeting. It was the consensus of Council to discuss the funding request on November 28th.

Council member Witkovich reported she attended the Adams County Council of Governments (ADCOG) dinner on October 26th and the Business Appreciation Awards on October 27th, where she presented an award to Animal Clinic North. On November 10th, Council member Witkovich attended the Parks and Recreation Advisory Board meeting. She stated two residents interviewed with the Board for the Ward 2 and 3 positions and noted the Board recommended appointment of the applicants.

Council member Jaramillo reported he attended the Northglenn Arts and Humanities Foundation (NAHF) annual retreat and was proud to report they are operating well enough to move from tier 3 to tier 2 for

Scientific and Cultural Facilities District (SCFD) funding, increasing the NAHF budget to over \$1,000,000. He reported the Northglenn Youth Theatre has doubled their youth attendance and involvement in courses and reported that Northglenn Arts Presents has brought in over 4,000 attendees and earned over \$75,000 in ticket revenue. Council member Jaramillo reported he attended the Business Appreciation Awards, and he looks forward to the event again next year.

Council member Goff reported she attended Problem Based Learning presentations at Northglenn High School on November 3rd addressing the topic of how to prevent student vaping. She reported the Ward 3 meeting on November 10th was well attended and included a good presentation from North Metro Fire Rescue District on fire prevention. On November 11th, Council member Goff attended the Veteran's Day ceremony and listened to statements from a Native American veteran and Council member Kondo who is also a veteran. Council member Goff expressed thanks for the Transgender Awareness Month proclamation.

Council member Kondo reported he spoke at the Veteran's Day ceremony and commended veteran Doug Goodfeather for a moving speech at the event. Council member Kondo expressed thanks to Don at the Maintenance and Operations facility for helping a resident remove yard waste. He reported the Ward 3 meeting was very useful, and the North Metro Fire Rescue District presentation helped educate residents on fire prevention. On October 26th, Council member Kondo had breakfast with City Manager Geyer and Council member Walker, then joined Council members Jaramillo, Lukeman-Hiromasa, and Goff at the North Metro Fire Rescue District training facility near the City's Wastewater Treatment Plant for firefighter training.

Council member Lukeman-Hiromasa reported she attended the American Public Works Association Awards event on October 25th with City staff where the city received an award for the new Recreation Center. On October 26th, Council member Lukeman-Hiromasa attended the ADCOG dinner with fellow Council members, in addition to the NMFRD tour. On October 27th, she attended the Business Appreciation Awards event and presented an award to Painted Tree Boutique. October 28th, she and Mayor Pro Tem Willford helped host students from North Mor Elementary who were touring City facilities. On October 28th, Council member Lukeman-Hiromasa had lunch with District Attorney Brian Mason, City Manager Geyer, and Council member Kondo and learned what the district attorney does in conjunction with the City. She stated they discussed youth and adult diversion programs and noted there is approximately a 95% success rate. It was the consensus of Council to direct City Manager Geyer to work with Judge Bailhache to evaluate a diversion program.

Mayor Leighty thanked the Police Department for the Safe Street Halloween event. Mayor Leighty reported she attended the Veteran's Day ceremony and thanked the American Legion Post 22 for their attendance and service. She reported the Metro Mayors Caucus is planning their annual retreat and recently completed their Habitat for Humanity Build Day.

City Clerk Small reported she participated in a Problem Based Learning event at Northglenn High School on October 28th regarding misinformation and elections and participated in the tours of City facilities for students from North Mor Elementary School.

Traffic Enforcement Strategy

Police Chief Jim May presented information to Council regarding the Department's traffic enforcement strategy including traffic unit staffing, calls for service, citations, patrol priorities, and enforcement measures.

There was discussion regarding speeding in residential areas and on different types of streets, the City's traffic safety initiatives, the Police Department's enforcement of speed limits primarily related to Fox Run Parkway and considering new tactics to address speeding in the City.

City Manager Geyer stated that staff will evaluate the use of safety sensitive zones and move forward with patrol related items to address the desired saturation approach, technology enhancements, and public education.
