PURPOSE

To provide City Council with an end of year update on the Municipal Court.

BACKGROUND

Court Operations

- Municipal Court is still holding dockets virtually for traffic and code violations. Municipal Court is looking into resuming in-person court for traffic and code. Participants are not appearing prepared for virtual court. Virtual court is not as efficient as it was originally.
- The Northglenn Juvenile Community Service Program continues to be held on Sundays. The program is still run by Community Service Coordinators Sarah Skarie and Eddie Blackwell.
- Community Resource Navigator Jayme Schledewitz and Crisis Response Unit Program Manager Jessica Hulse continue to be successful resources for defendants. Judge Amanda Bailhache continues to sentence some defendants to meet with Hulse as a condition of their sentence; it is a tremendously valuable alternative sentence.

Changes

 Court Supervisor Jason Johnson has put into place a text notification system for upcoming court dates. The system is not automated it takes Johnson about an hour to send out notification. Since June 2022, Municipal Court has sent out 2,667 text messages, with 2,310 texts delivered successfully, an 86.6% delivery rate.

- Johnson changed the format and now includes more substantiative information in the Municipal Court's monthly reports. Bailhache and Johnson believe that switching from quarterly to bi-annual court updates will be more informative. They would like City Council feedback on this proposed change.
- Municipal Court has launched a customer service survey that is available on the court website.

> Hulse, Bailhache and Johnson have developed a pilot problem-solving court named the Northglenn Community Court. Community Court has held two sessions. Community Court will be in session the 2nd Friday of the month in the CRU Resource Room during the resource hours. The goal of Community Court is to meet participants where they are at and hold them accountable. Community Court is a voluntary program however there are sanctions for non-compliance.

Upcoming Changes

- Municipal Court will be recruiting for the Full-Time Probation Officer position, approved in the 2023 City Budget, soon. Johnson plans on hiring in the first couple months of 2023.
- Another staffing shift is to provide a designated clerk for the City Prosecutor. This change was discussed during the 2023 City Budget process.
- Municipal Court has made substantial progress in preparing to go paperless. The transition will start with traffic cases.
