District Attorney Update

Brian Mason, District Attorney for the 17<sup>th</sup> Judicial District, provided an update to City Council and specifically addressed the dangers of fentanyl in the community.

District Attorney Mason addressed questions from Council regarding recent legislation and the prosecution of cases involving fentanyl, the distribution of fentanyl, educating the public about the dangers of the drug, and action steps to deter the use of fentanyl.

Attorney Mason spoke about partnering with the City on an outreach campaign and provided examples of outreach including an educational summit hosted by the City of Aurora. There was additional discussion and it was the consensus of Council to schedule a study session item regarding fentanyl.

District Attorney Mason also addressed questions from Council regarding auto thefts an gun violence.

Council member Kondo reported the Denver Regional Council of Governments (DRCOG) will have a working session discussing transportation, structure design, and homelessness. The meeting will be December 7 or 8 and he will provide more detail through City Manager Geyer if anyone would like more information about the event.

Council member Goff reported she participated in the OAF Committee meeting and attended the Pro Forma Furniture ribbon cutting event on November 18. Council member Goff reaffirmed the statements made earlier in the meeting regarding the tragedy at Club Q. She stated, on behalf of her transgender relatives, she feels personally impacted by this occurrence and is thankful for the welcoming places in Colorado.

Council member Lukeman-Hiromasa reported on the Legislative Policy Committee meeting where the focus was on the draft Legislative Issues Guide. Council Lukeman-Hiromasa reported the Ward 4 meeting is tomorrow night at Crossroads Community Center and looks forward to seeing the residents at the meeting.

Mayor Pro Tem Willford announced her intent to resign her position on City Council effective January 8, 2023 in order to serve the community as a representative in House District 34. She stated it has been an honor to serve on City Council and she is proud of everything Council has accomplished. Mayor Pro Tem Willford stated she will always be an advocate for Northglenn and thanked Council for the opportunity to serve with them.

Mayor Leighty congratulated Mayor Pro Tem Willford on her election to State House District 34 and reminded everyone to stay healthy and take care of themselves during cold and flu season.
