SUBJECT: CR-4 – Adams County Open Space Grant Acceptance – E.B. Rains Jr. Memorial Park Improvements

PURPOSE

To consider CR-4, a resolution approving a grant agreement and accepting grant funding in the amount of \$1.35 million to help fund the design and construction of improvements to E.B. Rains Jr. Memorial Park.

BACKGROUND

There are two opportunities each year to seek grant funding from Adams County Open Space (ACOS). Funding for these grants comes from the ACOS tax, of which 68% is distributed through a competitive grant process. Adams County Resolution 99-1 and the ACOS Policies and Procedures manual outline eligible uses for these funds.

Funding from this new grant would be used to renovate or replace the existing restroom facility, renovate the seating wall and the ADA pedestrian access trail, add hardscape improvements near the Don Anema Memorial Skatepark, and add a new storage facility with additional restrooms on the east side of the park. This new storage facility would be utilized by the Parks and Events divisions and would take the place of the storage areas that are in the current City Hall.

During the fall 2022 ACOS grant cycle, the ACOS Advisory Board recommended the grant request for the improvements to E.B. Rains Jr. Memorial Park be funded in full. That recommendation was accepted by the Adams County Commissioners, and a grant award of \$1.35 million was approved for this project.

The total cost of this project is estimated to be \$2.7 million; matching funds of \$1.35 million are available in the Capital Projects Fund.

BUDGET/TIME IMPLICATIONS

The grant agreement must be signed and submitted to the ACOS office within 45 days of award.

A supplemental appropriation increasing revenues and the corresponding expenditures in the Capital Projects Fund by \$1.35 million would be brought forward later in 2023.

Design work is currently underway. Construction is anticipated to begin in the fall of 2023.

A RESOLUTION ACCEPTING AN ADAMS COUNTY OPEN SPACE GRANT AND APPROVING THE GRANT AGREEMENT BETWEEN THE CITY OF NORTHGLENN AND THE ADAMS COUNTY BOARD OF COUNTY COMMISSIONERS

WHEREAS, the City of Northglenn has submitted an application to Adams County to use Adams County Open Space Sales Tax funding for the E.B. Rains, Jr. Memorial Park Renovation Project to provide a complete renovation or replacement of existing restrooms near the playground, sitting wall and pedestrian access trail replacement, skatepark hardscape enhancements, and the construction of a new Parks & Recreation storage facility with restrooms; and

WHEREAS, the Adams County Board of County Commissioners has approved the grant application and has prepared an Adams County Open Space Grant Agreement, which provides \$1,350,000 for the E.B. Rains, Jr. Memorial Park Renovation Project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. The Adams County Open Space Grant in the amount of \$1,350,000 is hereby accepted and the Adams County Open Space Grant Agreement, attached hereto as **Exhibit** 1, between the City of Northglenn and the Adams County Board of County Commissioners for the E.B. Rains, Jr. Memorial Park Renovation Project is hereby approved and the Mayor is authorized to execute same on behalf of the City.

ADAMS COUNTY OPEN SPACE GRANT AGREEMENT

The Grant Agreement ("Agreement") is made and entered into this day of , 202 , between the City of Northglenn ("Applicant") and the County of Adams, acting through the Board of County Commissioners ("Adams County").

RECITALS

WHEREAS, in November 1999, the citizens of Adams County passed a county-wide one-fifth of one percent Open Space Sales Tax (the "Tax"); and

WHEREAS, in November 2004, the citizens of Adams County reauthorized the Tax and increased it to one-fourth of one percent; and

WHEREAS, in November 2020, the citizens of Adams County authorized the permanent extension of the existing county-wide sales tax of one-fourth of one percent for the continuing purpose of preserving open space and creating and maintaining parks and recreation facilities; and

WHEREAS, the majority of the revenues collected are distributed to qualifying jurisdictions through a competitive grant process; and

WHEREAS, on September 16th 2022, Applicant applied for an Adams County Open Space Grant to complete the "E.B. Rains Jr. Memorial Park Renovation Project" (the "Project"); and

WHEREAS, on November 29th 2022, Adams County awarded Applicant an Adams County Open Space Grant to complete the Project; and

WHEREAS, Adams County awarded the Project 50% of the total Project costs, not to exceed \$1,350,000.00.

AGREEMENT

NOW, THEREFORE, the Parties hereto agree as follows:

- 1. <u>Grant Award.</u> Adams County hereby awards to Applicant a grant in the amount of 50% of the total Project costs, not to exceed \$1,350,000.00 (the "Grant"), subject to terms and conditions set forth in this Agreement.
- 2. <u>Project Scope.</u> Applicant shall complete the Project as described in the grant application, attached as Exhibit 1 ("Project Scope"), and incorporated herein by this reference. Exhibit 1 attachments include the grant application and all application attachments. Applicant shall not materially modify the Project Scope without the approval of Adams County. Applicant may request a modification to the Project Scope in compliance with the Modification Policy in the Open Space Policies and Procedures, attached as Exhibit 2 and incorporated herein by this reference, as may be amended from time to time by Adams County in its sole discretion. Adams County may elect to terminate this Agreement and deauthorize its funding for the Project in the

event it determines that the Project Scope has been materially modified without its approval and/or if Applicant fails to comply with the Modification Policy.

- 3. <u>Completion Date.</u> Applicant shall complete the Project no later than November 29, 2024 ("Completion Date"), which is two years after the date of Adams County's approval of the Project. Project completion requires all necessary documentation be submitted to Open Space staff on or before the Completion Date. Applicant may request an extension of the Completion Date in compliance with the Extension Policy in the Open Space Policies and Procedures, exhibit 2, as may be amended from time to time by the Board of County Commissioners in its sole discretion. Adams County may elect to terminate this Agreement and deauthorize its funding for the Project in the event that this Completion Date is not met and/or if Applicant fails to comply with the Extension Policy.
- <u>Compliance with Open Space Sales Tax Resolution and Open Space Policies and Procedures.</u> Applicant shall use the Grant in accordance with Resolution 2020-480, and the Open Space Policies and Procedures, collectively attached hereto as Exhibit 2.
- 5. <u>Audits and Accounting Records</u>. Applicant shall maintain standard financial accounts, documents, and records relating to the completion of the Project. The accounts, documents and records related to the completion of this Project shall be subject to examination and audit by Adams County staff (the "Staff") prior to receiving the Grant. All such accounts, documents, and records shall be kept in accordance with generally accepted accounting principles and be subject to an annual independent audit as set forth in Exhibit 2.
- 6. <u>Payment of Grant.</u> Adams County agrees to make payments to the Applicant in the following manner:
 - a. <u>Payments.</u> Adams County agrees to disburse grant funds to Applicant to provide reimbursement for the payment of project costs upon successful completion of the Project, or on a quarterly basis. Itemized Reimbursement Requests, as set forth below, are required for reimbursements. Should the Project take two full years to complete, the Reimbursement Request for the final period of the project must be received by November 29th, 2024 to remain compliant with the Project Completion Date, as set forth above. Reimbursements disbursed from Adams County shall not exceed 50% of project costs incurred during the previous period with cumulative reimbursements totaling no more than \$1,350,000.00.
 - <u>Acceptable Expenditures.</u> Applicant can request payment for 50% of all project costs incurred within the previous period with cumulative reimbursements totaling no more than \$1,350,000.00 that: (1) have already been paid by the Applicant, and (2) are listed in the approved budget attached as Exhibit 1, under Application Attachment A Project Budget. Applicant may request disbursement of grant funds for costs that have been incurred, but not paid by Applicant. However, Adams County will consider such

requests on a case-by-case basis and distribution of grant funds for these purposes is not guaranteed.

- c. <u>Reimbursement Request.</u> Applicant shall submit via hand delivery, email, or regular mail, to Adams County an itemized Reimbursement Request for project costs that have been incurred as of the date of the request. Each Reimbursement Request shall contain the following: (1) copies of invoices and/or employee time sheets complete with a spreadsheet indicating hours worked, wages earned, and taxes and benefits paid for work related specifically to the Project; (2) documentation substantiating that the Applicant has paid for the costs for which it is requesting reimbursement, including but not limited to cancelled checks or proof of a wire transfer; and (3) a brief summary of the work completed to date.
- <u>Approval of Payment of Reimbursement Requests.</u> The Adams County Open Space Program Manager shall approve or disapprove the amount of each Reimbursement Request within fifteen (15) days of receipt of a legible Reimbursement Request. Payment shall be made to Applicant by check or electronic fund transfer.
- e. <u>Disapproval of Reimbursement Request.</u> If Adams County disapproves any amount or amounts in a Reimbursement Request, Adams County shall promptly notify Applicant of the reason, therefore. Upon receipt of disapproval, Applicant and Adams County shall meet within one week to discuss what, if anything, the Applicant can do to obtain payment of the requested amount that was denied.
- 7. <u>Signage</u>. Applicant shall erect and maintain an Adams County Open Space Sign, which shall be provided by Adams County, in a prominent place on the Project site, unless the Project will not be open to the public.
- Publicity. In all press releases regarding this Project, Applicant shall include the following statement: "This Project was funded in part with proceeds from the Adams County Open Space Sales Tax. The Adams County Open Space Sales Tax was originally passed by the Adams County voters in 1999, and reauthorized and permanently extended in November 2020.

9. Miscellaneous Provisions.

- A. <u>Good Faith.</u> Both Parties have an obligation to act in good faith, including the obligation to make timely communication of information that may reasonably be believed to be of interest to the other party.
- B. <u>Applicable Law</u>. Colorado law applies to the interpretation and enforcement of this Agreement. Venue for any dispute shall be in Adams County, Colorado.
- C. <u>Time is of the essence</u>. Time is of the essence in this Agreement.

- D. <u>Authority.</u> The undersigned represents and warrants that he or she is duly authorized and has legal capacity to execute this agreement on behalf of the Applicant, that the Applicant's obligations in this Grant Agreement have been authorized, and that the Grant Agreement is a valid and legal agreement binding on the Applicant in accordance with its terms.
- E. <u>Survival.</u> The terms and provisions of this Agreement and Applicant's obligations hereunder shall survive the funding of the Grant.
- F. <u>Entire Agreement.</u> Except as expressly provided herein, this Agreement constitutes the entire agreement of the parties. No changes to this Agreement shall be valid unless made in writing and signed by the parties to this Agreement.

E.B. Rains Jr. Memorial Park is a heavily used, 22-acre regional park. The Park includes a variety of amenities including picnic pavilions, Webster Lake, pedal boats, a sensory playground, a skatepark, basketball court, large grassy areas for events or other community gatherings, walking trails and parking areas. As separate projects, the parking lots and the sensory playground will also be renovated this year. The project shall enhance safety and security, encourage proper use of the facilities, and lessen the maintenance burden with new and modified park assets. The goal of each of these projects is to refresh this well-loved community asset.

This project will consist of construction of the four primary components:

- A. Complete Renovation or Replacement of Existing Restroom near Playground
- B. Sitting Wall & Pedestrian Access Trail Replacement
- C. Skatepark Hardscape Enhancements
- D. New Parks & Recreation Storage Facility with Restrooms (adjacent to east parking lot).

This project will include two primary phases. Phase I, the design phase is currently in process. This funding request is for the construction phase, Phase II, of this renovation project.

At approximately 22 acres, E.B. Rains Jr. Memorial Park is a well-defined park space in the community. There is existing parking available to the east and west, as well as across the street at the Northglenn Civic Campus. There are trails and other physical barriers throughout the park with good separation between the renovations and the areas that will be engaged by users to and from the park. Crosswalks with a new signalized crossings will be added in 2023.

a. Clearly describe how this project will fulfill needs of the community (i.e. the project provides recreation opportunities for underserved areas, addresses health and safety issues, etc.). (<2,000 characters) This park is very well used by the community by individuals of all ages. There are amenities for nearly everyone, from the skatepark to the playground, walking, biking, running trails, a wavy walk for wheelchairs or scooters, pavilions for small family gatherings or large public events, large grassy fields for picnics and other recreation, paddle boats and fishing in the summer to name a few.

The park is located within walking distance from low-income housing areas, restaurants and shops, old city hall with new city hall in development now, and the new Northglenn Recreation Center, Senior Center & Theatre. The park is surrounded by the highest density of housing in the city. There are small townhouse homes on the north and east and apartments further to the west and to the north. There is senior housing just to the east, as well as single family houses. There are also childcare facilities and elementary schools within walking distance.

The park infrastructure and facilities are loved to death and in a desperate need of a renovation. The desired renovation not only helps the community users but lessens the maintenance burden. Modernization and utilitarian improvements of the facilities will enhance our staff's ability to adequately maintain the park and the Civic Campus of the city of Northglenn.

b. Explain the urgency to complete this project, including how the scope of the project will be affected if Adams County Open Space Grant funds go unsecured and what, if any, opportunities will be lost if the project does not receive grant funding this cycle. (<2,000 characters)

The improvements are currently in the design phase and the funding schedule would align perfectly for construction to begin once the students go back to school in the fall of 2023. Another matter of urgency is that the parks and events crews are losing their maintenance and storage facility with the construction of the new City Hall. When the Northglenn Police Department moved to the new Justice Center it created space in the current City Hall, the parks and events staff took advantage of the space once utilized by the police. The sally port at the City Hall became the hub for the Civic Campus' maintenance and special events storage, thus eliminating external storage containers and the need to haul equipment by trailer over two miles from the Northglenn Maintenance and Operations Facility. With the new City Hall design, the parks and events staff are losing this much needed space and we would like to recreate this hub in the park. This funding would allow for the projects to be completed simultaneously and in their entirety. The current ADA path and sitting wall is deteriorating and potentially a hazard. We would like to address these priorities of the city quickly and efficiently.

a. Describe all current and anticipated future uses of the project, including all programmed and nonprogrammed activities. (<2,000 characters)

The city of Northglenn is in the process of revitalizing its civic campus and that includes E.B. Rains Jr. Memorial Park. The park is expected to have a newly renovated playground in 2023 and hopefully an enhanced park with this project. This project will complete the renovation of this regional park and enhance the park amenities making them more user friendly, accessible, and vibrant. The park is the hub and the focal point for most of the city's events and activities. It is also a gathering spot for daily park users as well as our summer day camps. To better serve our constituents and our visitors alike, these new additions will only enhance all programmed and nonprogrammed activities for the city of Northglenn.

b. Explain how this project will appeal to a broad diversity of users or address the needs of specific groups (i.e. the project will provide facilities specifically for youth, the elderly, those with a disability, or will serve a combination of many groups). (<2,000 characters)

As a regional hub, this park project will enhance the users experience for a broad range of users and user groups. These facility enhancements will improve the restrooms in appearance and function and enhance ADA accessibility on all levels throughout the park. The renovations will include new sitting areas on the sitting wall along the walkway thus allowing individuals an opportunity to rest and enjoy the mountain view. A new accessible ramp will connecting the adjacent neighborhood to the park with a more appropriate slope for modern ADA compliance. The new restrooms on the east side of the park will replace the porta-johns with a plumbed restroom. The joint facility will act as storage and maintenance amenity that serves the park in which it allows for more visibility of park staff in the park.

The city of Northglenn's most recent Parks and Recreation Master Plan was adopted in 2017. This plan outlines the need for improvements at E.B. Rains Jr. Memorial Park. The project was identified in the 2017 Master Plan as an identified priority.

The city recently contracted with a consulting firm to conduct our next master plan update.

E.B. Rains Jr. Memorial Park is located along the Farms Highline Canal trail, and is adjacent to the Northglenn Recreation Center, Senior Center & Theater. It will used and well loved, by Northglenn residents (both current and past), but the park also has more regional draw. The Northglenn Civic Campus Master Plan has been developed an anticipated to take about 15 years to fully implement. This includes the new Recreation Center, Senior Center & Theatre, the new City Hall, housing, and small retail on the property just west of the park. This civic campus is between the Ramada and Wester Lake Promenade to the north and the apartment complexes to the south. There is also a trail connection under I-25 connecting the civic campus to the RTD Wagon Road, Park & Ride. The park has been viewed as a tremendous asset to that type of development and is a clear landmark for the project. With that development, the park use will only continue to increase.

The Parks Maintenance staff is composed of 20 crew members and one supervisor. Two of those crew members take primary responsibility for the maintenance of the Civic Campus property and E.B. Rains Jr. Memorial Park.

Staff conducts daily maintenance and the restroom facility cleaned and restocked daily. We have contracted a cleaning service to clean the restroom facility multiple times on the weekends during peak use. Each day park pavilions are cleaned; trash is removed, and debris is removed from the park and trails. During the summer months, turf areas are mowed approximately twice weekly.

The proposed improvements will minimally increase the maintenance requirements at this park, and we will continue to actively manage the ongoing maintenance at the park.





2021 Budget Annual Operating & Capital Improvement



General Fund expenditures total \$26,928,032. This represents a decrease over the 2020 Budget of 4.7%. The personnel line item is increasing by 2.8% due to increases in health care costs of 10.5% and salary adjustments for employees. Capital outlay has been decreased and other cost containment measures have been instituted as revenue recovery from the pandemic remains unknown.

The ending fund balance is estimated at \$20,471,865, or 77% of operating expenditures. Of the ending fund balance, \$19,664,024 is considered unrestricted. The City's fund balance policy requires a minimum reserve balance of 25% of its operating expenditures, a portion of which is restricted through the 3% TABOR Reserve Restriction.

Package requests in the General Fund include:

- \$1,018,312 On-going expenditures
- \$322,520 One-time expenditures
- \$301,000 Capital equipment expenditures

Conservation Trust Fund

Conservation Trust Fund revenue is projected at \$418,000 for 2021. The beginning fund balance is estimated at \$535,588.

Projects for 2020 include:

- \$250,000 Sensory Playground repair
- \$50,000 Greenway Trail replacement (sections of trail)
- \$10,000 Bocce ball court at Danahy Park

In total, the proposed expenditures are \$310,000 with an ending fund balance estimate of \$643,588.

Community Development Block Grant Fund (CDBG)

CDBG funds become available annually through Federal award and are distributed to the City by Adams County. The City does not budget for revenues or expenditures until the grant award is in place. If funding is allocated in 2021, estimated at \$225,000, the City intends to allocate the funds to the Minor Home Improvement Program administered through Adams County.

Capital Projects Fund

Capital Projects Fund revenue is estimated at \$8,646,600. Excluding grants, revenues are flat when compared to 2020 year-end projections. Overall, tax collections are estimated to increase 1.0%. These taxes include: 4.000 Mill Property Tax dedicated to road projects, ½% Sales/Use Tax and the 4% Special Marijuana Tax.

Total expenditures are \$42,658,141 which includes \$4,135,819 of debt service payments for the Certificates of Participation issued for the Justice Center in 2017 and Recreation Center issued in 2019.

- \$21,000,000 Recreation center construction (\$53 million total project cost)
- \$9,937,043 East 120th Avenue improvements from Washington Street to York Street
- \$1,350,000 Residential streets, traffic signals, and concrete programs
- \$1,200,000 Washington Street rehabilitation
- \$1,160,000 Traffic signal upgrade

- \$750,000 E.B. Rains Jr. Memorial Park renovations
- \$600,000 Community Center Drive Bridge maintenance
- \$500,000 City Hall planning and design work
- \$300,000 Wyco Park tennis court
- \$250,000 Other tennis court renovations
- \$136,951 School Zone Safety Program
- \$100,000 Citywide playground maintenance
- \$25,000 Miscellaneous emergency park repairs

Water Fund

Water Fund revenue is estimated at \$12,881,500. An estimated increase of 2.5% in sales tax and a rate increase of 3% for water usage lead to revenue being 2.1% higher than 2020 year-end projections.

Water Fund expenditures are \$13,790,032, which is greater than the 2020 Budget due to onetime capital projects planned in 2021. Total expenditures include \$1,014,760 for debt service payments on the Standley Lake Pipeline project. This debt will be paid in full in 2022.

Projects for 2021 include:

- \$3,500,000 Waste handling improvements
- \$418,000 Filter to waste automation
- \$150,000 Standley Lake pipeline
- \$100,000 Waterline replacement (citywide)

Package requests in the Water Fund include:

- \$531,000 Capital equipment expenditures
- \$413,520 Ongoing expenditures
- \$360,000 One-time expenditures

Wastewater Fund

Wastewater Fund operating revenue is projected at \$5,214,500. A rate increase of 8% to user charges and fees is included based on the rate plan approved in 2017. The increase is necessary to pay for infrastructure improvements that include replacing Lift Station A and the Force Main. These two components deliver the City's waste to the processing facility in Weld County.

Wastewater Fund expenditures total \$32,971,055, including an estimated \$1,097,636 for debt service created from the anticipated debt issuance for the required infrastructure improvements.

Projects for 2021 include:

- \$27,168,398 Lift Station A and Force Main replacement (estimated \$28.5 million total project)
- \$500,000 Clarifier rehabilitation
- \$330,391 Collection system rehabilitation
- \$168,103 Lift Station B assessment

Package requests in the Wastewater Fund include:

- \$385,000 Capital equipment expenditures
- \$21,220 Ongoing expenditures
- \$0 One-time expenditures
