## BOARD of DIRECTORS

## **Meetings**

The Youth Commission Board of Directors holds a meeting on the first and third Tuesday of each month at 7 p.m. The first meeting of the month is a formal business meeting; the second is a working meeting. Agendas and minutes, along with other board documents, can be found at www.northglenn.org/NYC. All Youth Commission meetings are open to the public. Youth who are interested in joining the Youth Commission, or those that have an idea to share, are encouraged to attend.

## Join the Board

To be eligible, interested youth must be between the ages of 13 and 18, and live in Northglenn or attend school in the Adams 12 Five Star School District. Applications are available on the city's website at www.northglenn.org/nyc.

## **Board Openings**

As of December 2022, there were 10 vacancies available on the Youth Commission's Board of Directors and two pending applications to be finalized in 2023. During 2022, several applications were submitted, and one new member joined the board. The openings are posted on the Youth Commission's webpage, social media, Northglenn Recreation Guide, and have been promoted in the Northglenn Connection, a direct-mail postcard to residents, and on social media. Additional outreach was done to fill vacancies by having a presence at Northglenn events and local back-to-school nights, increasing social media presence and updating language on existing outreach efforts to be more inclusive.

## **COMMUNITY ENGAGEMENT**

## **TCHD Healthy Beverages**

The Youth Commission continued to assist the Tri-County Health Department (TCHD) Healthy Beverages Committee in 2022. Over summer break, Élizabeth and Isaiah developed informational activity booklets for children to be handed out to summer camps and schools. They led a presentation about how to make healthy beverage choices for the Northglenn Day Camp and provided them with some of the booklets to take home.

In September, staff from the TCHD (now Adams County Health Department) joined a Youth Commission work meeting to present a documentary titled "EI Susto." This film was about the effects of widespread Coca-Cola marketing in Mexico and how the daily consumption of sugary soda has led to life-limiting health issues for millions of Mexican families. This documentary influenced Meera and Nazly to join the Healthy Beverages Committee.



TCHD's Healthy Beverages Committee continues to work on passing a local ordinance that requires Northglenn restaurants to advertise healthier drink options in kids' bundle menus. Sugary drinks for kids would still be available by request only, but the marketed drink of choice would include milk or water.

## **Gaming with the Chief**

While collaborating with the Diversity, Inclusivity, and Social Equity (DISE) Board on a priority project, the Youth Commissioners were introduced to Chief May, the Chief of Police with the Northglenn Police Department. Chief May talked with the Youth Commission about wanting to connect police officers with youth in Northglenn by running a 'Gaming with the Chief' activity either at schools, at the Recreation Center, or at the Police Department.

The Youth Commission provided feedback, recorded content for a video advertisement, and offered to help make the flyer for the Chief's Info Session.

Staring February 1, 2023, Gaming with the Chief now takes place at the Northglenn Recreation Center during the Wednesday Club REC teen program. During that time, youth ages 10 to 17 can play video or board games with Chief May and other police officers.

## **PRIORITY PROJECTS**

## **Address Homelessness**

Homelessness is a growing problem in Colorado, and Youth Commission was proud to show continued support for people experiencing homelessness (PEH) this year. Projects that Youth Commission have done this year include: assisting PEH by purchasing supplies for meals served at the City's temporary shelter, meeting with the Northglenn Crisis Response Unit (CRU) to learn about CRU and issues that people experiencing homelessness are facing, and meeting with the director of ACCESS Housing to coordinate a drive for children experiencing supply school homelessness. The first pop-up supply drive was at Noel Northglenn. In 2022, Youth Commission made a dent in this crisis.

### **D.I.S.E. Power Imbalance**

The 2021 listening session sparked the Youth Commission's desire to uplift youth voices and be more involved with the Diversity, Inclusivity, and Social Equity (DISE) Board in 2022.

This began with Youth Commissioners sitting in at DISE Board meetings to gain an understanding of the DISE Board's goals and needs in the community. The Youth Commission then invited a DISE liaison to attend a Youth Commission meeting and explore ways that their combined efforts could make an impact for youth in the community. The Youth Commission and DISE Board then held a joint meeting in May and decided to collaborate at the AAPI booth during Food Truck Carnival.

The Youth Commission also spoke with a representative from Adams County Pride and provided advice and guidance on youth-focused activities for their Pride event, supported the use of gender-neutral language in the Municipal Code, and normalized the use of asking about preferred pronouns at Youth Commission meetings, activities and events.

The community involvement that spawned from these partnerships are now become ingrained in future Youth Commission priority projects.
