SUBJECT: CB-1896 Amending Section 8-2-3 of the Northglenn Municipal Code Regarding

the imposition of Court Costs to cover fees associated with sealing records

#### **PURPOSE**

City Council is considering an ordinance to approve a sixty five dollar (\$65.00) fee to cover costs associated with sealing records.

#### **BACKGROUND**

Said ordinance was approved on first reading on Monday, September 11, 2017.

The General Assembly in the 2017 legislative session adopted certain expedited processes for sealing the criminal records of persons: (1) who were acquitted; (2) whose cases were completely dismissed; (3) who completed a diversion agreement; or (4) who completed a deferred judgment and sentence. HB17-1208 clarifies the process which allows defendants in Municipal Court to ask the court to seal their records immediately, rather than going through the District Court process. In addition to granting the court the authority to seal these records, HB 17-1208 also allows the Municipal Court to propose the sixty five dollar (\$65.00) fee.

## **BUDGET/TIME IMPLICATIONS**

Any fees collected will be put into the Court Costs line item and the money will be placed in the City of Northglenn's general fund. The Court is not anticipating a significant increase in revenues with the passage of this bill.

### STAFF RECOMMENDATION

Staff recommends approval of the attached ordinance, allowing the court to follow the guidelines outlined in HB 17-1208 which take effect September 1, 2017.
