Procurements for the following are eligible for award by competitive sealed (a) proposals: Materials and services when the City Manager, or the City Manager's designee, determines in writing that the use of competitive sealed bidding is either not practicable or not advantageous to the City based on the specialized nature of the materials and/or services sought by the City; Professional services, EXCEPT PROFESSIONAL SERVICES PAID FOR (2)IN WHOLE OR IN PART BY FEDERALLY FUNDED GRANTS, IN WHICH CASE SAID SERVICES SHALL BE SOLICITED AS REQUIRED BY FEDERAL REGULATIONS AND ACCORDING TO THE CITY'S WRITTEN PROCEDURES; and City improvements when the City Manager or the City Manager's designee determines in writing that the use of alternative delivery methods will provide substantial benefit to the City while retaining sufficient competitive pricing and/or performance.
