SUBJECT: Small Business Resource Guide

The small business resource guide is a snapshot of information and resources intended to assist businesses with common business questions. The resource guide is not intended to fully answer all relevant questions for each topic, but rather to quickly point the business to resources that can help them with their particular issue.

The guide will be used as a tool at the first point of contact with the City. Businesses often contact different departments depending on their particular question. By putting the resource guide in the hands of the people first contacted by businesses, we are enhancing the City's ability to provide a clear and consistent message of the resource the community has to offer businesses. This resource guide will also be part of a welcome packet to new business.

Funding for the printing of this resource guide is in the 2011 Northglenn Urban Renewal 2011 budget. The guide will be printed and distributed during the first quarter of 2011. The resource guide will be checked for updated information in the fourth quarter of each year and be reprinted as updates are required and budget allows.

City of Northglenn Resources

Commitment to Service

The city of Northglenn and the Northglenn Urban Renewal Authority (NURA) will always provide property owners, business owners and developers with the highest level of pre-development review in an effort to educate people about opportunities and save pre-development dollars. The city also works to expedite the permitting and planning process.

Sign Permits

The city recognizes that commercial businesses needs signage. Commercial signs must meet the standards the city has established for each of the city's zone districts. The Planning and Development Department administers sign regulations and permits. They have copies of the regulations available that fully explain what is allowed. A sign plan must be submitted and approved for all new signs prior to being presented to the Building Division for approval of the construction via a building permit. Permits are not needed for certain signs, and the Planning and Development Department can help you determine what is required. You may change the copy or message on a legally-established sign without a sign permit. However, any other modifications (electrical, structural) require a permit.



Depending on the nature of your proposed project or activity, various levels of review and permitting may be required. Your initial contact with a staff member will help determine if submittal to the city's Development Review Committee (DRC) or other permits are required for your proposed project.

Zoning

All properties within the city are zoned. Zoning regulates what land uses are allowed and establishes rules for how property can be developed (i.e., setbacks, height restrictions, etc.). There are many different zone districts within the city, including residential, commercial and industrial.

Before signing any sale, lease or rental agreements call the Planning and Development Department. This is a safeguard to help you determine where you can legally locate your business. Please note that this is also true for home-based businesses.

Change in Use

A change in the use of land or buildings may arise by a simple alteration in the nature of the use, or through alterations and additions which modify the use. There are certain types of change of use which do not require planning permission. Before moving forward with any business that is a change in use to any building or land use, contact the Planning and Development Department for requirement clarifications.

The North Metro Fire Prevention District works to ensure all buildings in our community meet locally-adopted fire codes and hazardous material regulations. Inspections are conducted during the construction, remodeling and operational stages of all commercial and public buildings.

Requests for all inspections and acceptance testing of fire protection systems must be made and confirmed with the Fire Prevention District at least two business days in advance. Reinspection fees may apply for any failed inspection that requires an inspector to return to a site for further testing or inspection.

Business Licenses and Taxes



City Licensing

All businesses operating in Northglenn must apply for a sales tax or use tax license. Even Northglenn businesses that do not "sell" anything must obtain a City Use Tax License. Persons making infrequent taxable sales must obtain a license to collect and remit the city tax. The licensing process ensures that the area is properly zoned for the activity and that the city has a record of the business information. It takes approximately five to 10 days to issue a new license, depending on the complexity of the new business. Businesses must obtain a license before opening to the public. The cost of a license is \$15 and must be renewed every year by Dec. 31.

State Sales Tax Licensing

If you sell, rent or lease tangible personal property in Colorado, you must obtain a state sales tax license. A 2.9% state sales tax must be collected by all businesses selling tangible, personal property located in Colorado. For a general sales tax reference guide, DRP 0099 is at www.taxcolorado.com.

City Sales Tax

The city sales tax must be collected on all sales, leases and rentals of items in the city, including items delivered into the city. Certain services such as cable television, telephone, gas and electric are also taxable. Professional services such as accounting, advertising and legal are generally not taxable.

Northglenn sales tax must be charged on merchandise delivered to purchasers located within the city. Northglenn sales tax should not be charged on merchandise delivered to purchasers located outside the city. Contact the city where an item is being delivered to determine if that city's sales tax should be collected. City boundaries are difficult to identify and mailing addresses do not always correspond to the correct boundaries. Be careful not to rely on mailing addresses to decide which tax to collect.

State Sales Tax

If you sell tangible personal property to anyone in Colorado, you need to collect retail sales tax. (If the sale is made inside Northglenn, you must also collect city sales tax). A retail sale is taxable unless what is being bought is to be resold or used to manufacture something else. Sales tax is not imposed on the sale of real property. If you do not plan to request the "Business Start-Up Kit" from the Small Business Assistance Center, you may apply for your sales tax license at the local office in Denver.

State Use Tax

Northglenn Small Business

Resource Guide

This tax is a complement to the sales tax and is imposed on the storage, use or consumption of tangible personal property brought into Colorado on which sales tax has not been paid. The amount of tax is paid on the purchase price or fair market value. If you purchase tangible personal property when buying a business (furniture, fixtures, equipment, supplies) and did not pay sales tax at the time of the sale, you as the purchaser are liable for the state and city use tax.

State and Federal Withholding, FICA & W-4

Employers are required to withhold an amount for the payment of state and federal income tax and FICA from the wages paid to their employees. Employers are further required to match their FICA payment and pay a state and federal unemployment tax. It will cost an employer 12% to 15% of the amount paid for wages to cover the various taxes and Worker's Compensation Insurance, even if he/she does not provide any additional benefits. These must be paid on all employees, full or part time, with the exception of independent contractors. It is necessary to fill out a W-2 form for each employee at the end of the year. Payroll services are available and recommended for any business with greater than one employee.

To obtain a Colorado tax I.D. number, sales tax account and a Colorado wage withholding account, complete the Colorado Business Registration (CR-100), available online.

Independent Contractors

Both the IRS and the state have tightened their rulings of who can be classified as an independent contractor. Generally, if a person is paid by the hour or day, and not by the job performed, require a uniform, furnish tools of the trade or provide any supervision over the performance of the work, the chances are you have an employee and will be required to pay the tax. To be completely sure, you should contact the IRS, the Colorado Employment Office and the Colorado Department of Revenue. You must issue a form 1099 if your business is not registered as a corporation.

Mileage and Fuel Tax

If you operate a truck exceeding 10,000 pounds empty weight, you will be required to apply for a Mileage and Fuel Tax account. If you do not travel beyond a 25-mile radius of the city limits, you may apply for a metro plate at the county motor vehicle office rather than setting up a Gross Ton Mileage (GTM) account.



Personal Property Declaration

Each year you must file with the county assessor a statement as to the original cost, year acquired and description of your personal property (furniture, fixtures, and equipment) which is used in your business. If you have not received the form by the first week of February, you should contact the Adams County Assessor's Office. The form must be filed no later than April 15 of each year. This serves as the basis for determining your assessed value. The person who owns the property at noon on Jan. 1 of any given year is liable for the assessment for the entire year. The Assessor's Office does not prorate the assessment. If you wish to protest the assessed valuation of the property, this must be done between June 20 and July 10 at the Assessor's Office.

Personal Property Tax

Personal Property Tax is imposed on income-producing tangible personal property. Even though the value of your personal property is assessed in January, you are not mailed a tax bill until January of the following year. If you purchase a business, you should contact the Adams County Treasurer's Office to determine the status of the taxes. A search should be done by the name of the business and by the address. A tax search is important because unpaid personal property taxes are a lien against the property.

Workers' Compensation

All employers in Colorado are required to have Worker's Compensation coverage if they have any employees for any length of time. Corporate officers (owning 10% or more of corporate stock) who work actively in the business must be covered unless they elect to reject the coverage in writing. Sole proprietors and working partners must have the option of electing the coverage. All premium costs are to be made by the employer.

Vehicle Use in Your Business

If your vehicle is used for commercial purposes in your business, it requires a commercial vehicle license. If gross vehicle weight is 26,001 pounds or higher, a commercial driver's license is required, otherwise the vehicle may be operated with a normal operator's license. The Colorado State Highway Department regulates the size and weight of vehicles operating on Colorado highways.

Unemployment Insurance

The Unemployment Insurance Fund is a fund established by law to provide benefits to employees who lose their jobs through no fault of their own. Several factors can determine the benefit amount. The employer is required to pay state and federal unemployment insurance tax on wages paid to all employees. The federal unemployment insurance rate is 6.2% on the first \$7,000 in wages paid to each employee every year. As a new employer, you should qualify for a 5.4% credit for an effective rate of 0.8%.

Registering Your Business Name

Whether you have decided to operate your business as a sole proprietorship, general partnership or corporation, or if you plan to operate your business with a trade name other than your own legal name or the true name of the corporation, you must register with the State Department of Revenue. As a limited liability partnership, corporation or LLC, you are required to register the name with the Secretary of State, Business Division.

Article of Incorporation

Corporations, limited partnerships and limited liability companies file organizational paperwork with the Colorado Secretary of State. Sole proprietors, general partnerships and all other organizations should still register trade names.



Incentive Grants – Incentive grants are for companies that are relocating to Colorado or are already located here and undertaking a major expansion. Grant awards are typically based on the number and quality of the jobs created.

Competitive Grants — Competitive grants are for companies adding a significant number of new full-time jobs to their Colorado-based business. Training content and delivery must take place during the fiscal year (July 1 to June 30). There are five grant periods each fiscal year: June, August, October, January and March.
