Northglenn Marketplace Update

There are three owners of the Northglenn Marketplace. The largest portion that consists of everything except Lowe's, and the Arrowrock property that includes the K&G, Tuesday Morning, and Woodley's is being sold. The property being sold is currently owned by Starwood Property Trust, and their special servicer is LNR Properties. Farris Lee Investments is marketing the 439,063-square foot property on behalf of its owner. Initial bids closed on March 24th, and the top bidders will then be evaluated, and invited to participate in an auction for the property in April. National SBDC Day

March 22, 2017 was proclaimed as *National Small Business Development Day*. The day recognized the success and impact America's Small Business Development Centers (SBDCs) have across the nation in economic development and the small business community. SBDC Day is a national movement to help share the small business success stories and notable impact SBDCs have fostered in communities nationwide. Business has changed dramatically over the last 30 years. Colorado's SBDC is the only statewide program of its kind and has helped aspiring and emerging small business owners achieve the American dream of entrepreneurship.

North Denver SBDC Receives Excellence & Innovation Award

The North Metro Denver Small Business Center (SBDC) located at the Front Range Community College in Westminster since 1989, received the State of *Colorado 2017 SBDC's Excellent and Innovation* award based on the center's efforts to effectively assist small business owners, and its innovative approach to serving small manufacturers throughout Colorado. Since 2011, under the leadership of Glenn Plagens, Senior Director of the North Denver SBDC has grown consulting over 500%. In an effort to better serve the state's small manufacturing clients a "Beta manufacturing" program was developed. The SBDC worked intensively with four small businesses of over a 2.5 year period, which led to the creation of 23 jobs, \$5,200,000 in capital formation and \$4,002,000 increased sales. The North Denver SBDC continues to be a great resource and partner for the city's economic development efforts, and support to Northglenn businesses.

Why Northglenn is one of the Hottest Zip Codes

The *Denver Post-Your Hub* published an article on March 15, 2017 regarding the national recognition that Northglenn got last year as the "third hottest zip code" in the nation. The recent article identifies the "larger than normal millennial population, and it's in an area of economic growth and job market, so houses stay on the market for an average of 11 days," according to Realtor.com. The article also cites that real estate experts believe Northglenn's rating was driven by other reasons, including the large number of sustainable brick-constructed homes, sense of place and character, unique housing stock, its excellent location along I-25, attainable home prices and time to sell properties, and the future FasTracks light rail system. 


Businesses Advertise on the Digital Billboard
