BACKGROUND

In October of 2009 the City of Northglenn (City) received notification that it was selected to receive funding in the amount of \$5,303,268 for the reconstruction of Huron Street from W. 112th Avenue to W. 104th Avenue. The initial funding obligation was met through a grant by the American Recovery Reinvestment Act (AARA). Denver Regional Council of Governments (DRCOG) administered the grant funding. Due to favorable bid climate the low bid was in the amount of \$3,703,974.19 from Castle Rock Construction (CRCC). The final contract award including built in force account items required by CDOT was \$4,153,079.19.

FINAL PAYMENT

Construction complexities including excess muck excavation and sub-grade stabilization caused the project to exceed its budget. The actual budget overrage was calculated from the final billing received in September of 2011. A change order to CRCC in the amount of \$172,550 is needed to issue final payment and initiate the close-out of the project with the contractor and CDOT. The final change order amount of \$172,550 (4%), if approved, will be Northglenn's total contribution to the cost of the roadway construction.

BUDGET/TIME IMPLICATIONS

According to the 2011 year-end estimates, sufficient funds are available via the 4.000 mill levy and/or unassigned fund balances. If necessary, staff will submit an Appropriation amendment at the end of the fiscal year in accordance with standard practice.

RECOMMENDATION

Attached to this memorandum is a Resolution that, if approved, would:

1) Authorize the City Manager to execute a Change Order to the contract between the City of Northglenn and Castle Rock Construction Company for the *Huron Street Reconstruction Project* in the amount of \$172,550.

Staff recommends approval of the proposed Resolution.
