Council member Dodge reported she had attended the candidate forum last week and noted it should be replayed on Channel 8 soon. Council member Dodge reminded everyone about the grand opening event for the Don Anema Memorial Skate Park on Saturday, September 24, 2011 and stated the North Metro Chamber of Commerce's Taste of the Chamber event would be held on October 4th. Council member Dodge reported that the Youth Commission has

been busy working on Safe Street Halloween and a Club 22 event, and noted there is a need for additional members on the Commission.

Council member Carrico reported on the Sparkopolis event to be held at the Anythink Library on Saturday from 6:00 p.m. to 10:00 p.m. to raise funding for public art. Council member Carrico reported the Northglenn Community Foundation is working to advertise the Utility Assistance Program and is meeting monthly to review grant applications for the program. Council member Carrico also reported that the Foundation will be raising funds at the Noel Northglenn event and will be placing a bench at the Don Anema Memorial Skate Park in memory of Mr. Anema. Council member Carrico reported on the Northglenn Thornton Rotary Club's recent Ducky Derby and the North Metro Fire Rescue District's emergency services program.

Mayor Pro Tem Clyne reported that a program featuring the music of Scott Joplin would be held at the Stonehocker Farmhouse on Saturday, September 24th at 7:00 p.m. Mayor Pro Tem Clyne reported on the tour of rehabilitated homes she attended with Council member Brown and NURA Commissioner McCune, and noted that a parade of the homes would be held on October 22, 2011 from 10:00 a.m. to 2:00 p.m.

Council member Brown reported on the Planning Commission and stated the Final PUD for TH Automotive had been approved.

Council member Paiz reported on the Rocky Flats Stewardship Council and announced that the dams are now operating in the flow-through system. Council member Paiz provided information about the Rocky Flats Stewardship Council IGA and noted the agreement has been scheduled for Council's review at the October 6, 2011 study session.

Council member Snetzinger reported that a Ward IV meeting would be held on Monday, October 3, 2011 at Shepherd's Hall. Council member Snetzinger reported on the Northglenn Urban Renewal Authority (NURA) and the new Business Improvement Grant Program, which was created to assist commercial property owners and businesses within the urban renewal area. Council member Snetzinger reported on the Northglenn Arts & Humanities Foundation, the Northglenn's Got Talent event, the Theatre production of Seussical, and the upcoming dedication of the Blooming Pink Amaryllis sculpture. Council member Snetzinger reminded everyone to get out and vote in the election this November.

City Clerk Small reported the deadline to register to vote in the November election is Monday, October 3, 2011. City Clerk Small
