PUBLIC HEARING: LICENSE RENEWAL

Tafo's, Inc. dba Tafolino's 516 Malley Drive

Mayor Pro Tem Tichy read the procedures to be used into the record for the public hearing for the license renewal application for Tafo's, Inc. dba Tafolino's located at 516 Malley Drive.

Mr. Juan Tafoya was sworn in by Deputy City Clerk Small.

Mr. Tafoya provided testimony about the items addressed on the background investigation for his liquor license renewal application. He stated he does not feel the alcohol incident card that was presented to the Authority is correct. Mr. Tafoya stated his restaurant works hard to prevent selling to minors and asked the Authority to renew the liquor license for Tafolino's.

There were questions from the Authority about question number five on the renewal application, the alcohol incident card, the violation of selling alcohol to a minor from October 2004, and Mr. Tafoya's knowledge of the ordinance to cite the licensee as well as the employee for selling alcohol to minors.

Mr. Tafoya stated his accountant had completed the application and had answered the question relating to previous suspensions incorrectly. He stated the restaurant did not serve alcohol to a minor as shown on the alcohol incident card from April 2005. He stated he does not know why the information shows the case from October 2004 as pending, because the employee has gone to court and the license was suspended for the violation by the Authority.
