## **DISCUSSION ITEMS**

Code Enforcement

Councilman Lindsey stated there are obvious code violations throughout the City and he would like these violations corrected. Councilman Lindsey stated he feels the code violation process is not fast enough and he would like the city to be more aggressive in its efforts. He stated his objectives are to improve Code Enforcement's approach in dealing with violations, to budget more funding for abatements if needed, to get Council's commitment for supporting citations that are issued, and to review ordinances relating to enforcement.

Councilman Lindsey stated he would be willing to volunteer his time to sit on a task force to review the code enforcement procedures and develop solutions efficiently.

There was discussion about the Judge's involvement in code violation cases, the Clean Sweep program that will begin in a few months, and staff's efficiency in enforcing the ordinances.

Police Chief Russ Van Houten provided information about the Clean Sweep program and the types of violations it will address. He spoke about code violations and the correlation between it and other factors in the community. Chief Van Houten spoke about the importance of addressing long-term solutions along with quick wins.

> Councilman Lindsey recommended using a task force to work on code enforcement, and reiterated that he would like the obvious code violations corrected immediately.

Mayor Pro Tem Tichy invited any member of the public wishing to speak on any subject to come forward.

Mr. Dallas Briggs, Ward I, spoke to Council about graffiti. He stated he would like to see a \$500 reward given to people that catch and report persons that graffiti property in the City. Mr. Briggs stated he enjoyed Councilwoman Carlow's invocation and also spoke about the Judge imposing penalties for code enforcement violations.

Ms. Maridee Marks, 11076 Elati Street, spoke about code enforcement. Ms. Marks stated she is thankful for the residents that received beautification awards tonight. She also spoke about the City maintaining its property as well as residents. Ms. Marks spoke about the new clean up project and ways to improve the appearance of the city.

Mr. James Miller, Ward I, spoke about code enforcement and offered to work with the City to improve the enforcement process. Mr. Miller spoke about the Judge's interpretation of the codes, the abatement process, and the involvement of staff and Council in the enforcement process.

Joel Igli and Matthew Igli thanked Council for supporting their Eagle Scout projects. Joel and Matthew spoke about the projects they completed for the MAGIC Garden, located at Crossroads Assisted Living facility, and the contribution they have made to the community.
