Assessments. An assessment of five dollars (\$5.00) TEN DOLLARS (\$10.00) is imposed hereby for each assessed violation. The assessment shall be mandatory and be in addition to all fines, penalties, charges, fees, and similar monetary impositions. The Municipal Court shall not have jurisdiction to suspend, reduce, waive, or otherwise fail to impose the full assessment of five dollars (\$5.00) TEN DOLLARS (\$10.00) except where the court imposes a jail sentence as a penalty for a violation, and except where a defendant is jailed for the failure to pay a fine. The assessment shall be paid to the Clerk of the court by the defendant, and the Clerk shall pay the assessment into the unapportioned Victim Assistance and Law Enforcement (VALE) fund established to carry out the purposes of this Article.
