APPROVAL OF MINUTES

February 10, 2005 The minutes of February 10, 2005 were approved as presented.

PUBLIC HEARING New License Application

Wingman Operating Co. Inc.

dba Wingman

1450 W. 104th Avenue

Mayor Novak read an opening statement for the procedures to be used for the public hearing for the beer and wine liquor license application for Wingman Operating Co. Inc., dba Wingman located at 1450 W. 104th Avenue.

City Clerk Lentz swore in Mr. Karl Kigerl and Mr. Joseph Martin, corporate officers for Wingman Operating Co. Inc.

Mr. Karl Kigerl, applicant, provided testimony about the business and stated they had previously held a liquor license at this location. Mr. Kigerl stated they had surrendered their liquor license because of a violation they received and they are now reapplying for the license due to customer demand and competition from other wing restaurants.

Mr. Joseph Martin, applicant, spoke about the corporation's desire to have a liquor license at this location and provided information about customers' requests for alcohol beverages.

There were questions from the Authority about the restaurant's training procedures and the consequences for employees that violate the liquor laws.

Mr. Kigerl stated that they have hired more managers to allow one manager to be at the cash register at all times. He stated they have Northglenn Liquor Licensing Authority February 24, 2005

updated their training manual and their policy will be to ask every customer for identification if they order an alcoholic beverage. Mr. Kigerl stated that any employee violating the liquor laws would be terminated. Mr. Martin stated their employees are aware of the mandatory \$500 fine that would be imposed by the court if they sold alcohol to a minor.

There was discussion about the violation that occurred in 2003 and the absence of a penalty imposed by the Liquor Authority.

Mayor Novak asked anyone interested wishing to speak either "for" or "against" the liquor license application to come forward.

Mayor Novak closed the public hearing.

Mayor Novak **MOVED** and it was **SECONDED** by Ms. Carlow to approve the application for a beer and wine liquor license for Wingman Operating Co. Inc. dba Wingman located 1450 W. 104th Avenue.

Ms. Garner asked that the City of Thornton be notified of this application because of the proposed location. There was discussion about the notification requirements for new liquor license applications.
