SUBJECT: CR-47 – Karl's Farm Metro District Director Appointments

PURPOSE

To consider CR-47, a resolution appointing members to the Board of Directors of the Karl's Farm Metropolitan District No. 3.

BACKGROUND

The Karl's Farm Metropolitan District No. 3 Board of Directors was inadvertently disqualified recently when the Board's parcel was sold for development. The Board is required to have a parcel of ownership to serve the District. As a result, the Board has identified a new parcel to own, a private road between 120th Avenue and 121st Avenue (Attachment 2).

The board for Karl's Farm Metropolitan District No. 3 was inadvertently disqualified recently. Pursuant to Section 32-1-905(2.5), C.R.S., "[i]f there are no duly elected directors and if the failure to appoint a new board will result in the interruption of services that are being provided by the district, then the [governing body of the municipality] which approved the organizational petition may appoint all directors from the pool of duly qualified, willing candidates." This is the commercial district, so there are no other eligible electors that can be appointed other than the developer representatives.

We are requesting that the City Council consider the reappointment of the board at the next available meeting. Enclosed with this letter is a proposed resolution for consideration. 

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORTHGLENN APPOINTING DIRECTORS TO THE BOARD OF DIRECTORS OF KARL'S FARM METROPOLITAN DISTRICT NO. 3

WHEREAS, the Karl's Farm Metropolitan District No. 3 (the "District") is a special district located wholly within the boundaries of the City of Northglenn, Colorado; and

WHEREAS, the District operates pursuant to the District's Service Plan, approved by City Council on April 8, 2019 (the "Service Plan"); and

WHEREAS, the District's Board of Directors is vacant, and the District is unable to take any formal action, which has resulted in the interruption of the District's services; and

WHEREAS, the City Council is authorized to appoint individuals to a district's board of directors if the board of directors is entirely vacant and the failure to appoint a new board will result in the interruption of services that are provided by the district, pursuant to § 32-1-905(2.5), C.R.S.; and

WHEREAS, the City Council has received a request for appointment to the District's Board of Directors from the following qualified individuals within the District: David Goldberg, Daniel Frank, Richard Frank, Marc Cooper, and Steven Shoflick (collectively, the "Proposed Directors"); and

WHEREAS, the City Council finds that appointment of the Proposed Directors will facilitate the District's compliance with local government laws and allow the District to resume services as contemplated by District's Service Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

<u>Section 1</u>. The City Council determines that failure to appoint qualified individuals to the District's Board of Directors will result in the continued interruption of District's services and result in noncompliance with certain state laws pertaining to local governments.

Section 2. Pursuant to § 32-1-905(2.5), C.R.S., the City Council hereby appoints the following qualified individuals to serve as the District's directors:

David Goldberg May 2025; Daniel Frank May 2025; Richard Frank May 2027; Marc Cooper May 2025; and Steven Shoflick May 2027.
