SUBJECT: CB-2019 – Unified Development Ordinance Amendment

PURPOSE

To consider CB-2019, an ordinance on first reading amending Section 11-3-3(e)(1) of the Municipal Code regarding commercial uses.

BACKGROUND

The policy addresses commercial uses under the Unified Development Ordinance (UDO) by limiting commercial sales on public and private property to those with permission of the landowner or the landowner's designee. The intent of the regulations is to prevent unsolicited vendors on public and private property, where in certain cases those sales may pose a life-safety concern of nuisance to the vendor or the public.

The proposed amendment was presented to the Planning Commission on April 2, 2024. The Commission unanimously approved a resolution recommending City Council approval of the UDO amendment.

BUDGET/TIME IMPLICATIONS

There are no financial impacts.

If CB-2019 is approved on first reading, a public hearing and second reading of the proposed ordinance will be scheduled for April 20, 2024.

STAFF RECOMMENDATION

Staff recommends the approval of CB-2019 on first reading.
