SUBJECT: CB-2019 – Unified Development Ordinance Amendment

PURPOSE

To consider CB-2019, an ordinance on second reading amending Section 11-3-3(e)(1) of the Municipal Code regarding commercial uses.

BACKGROUND

The policy addresses commercial uses under the Unified Development Ordinance (UDO) by limiting commercial sales on public and private property to those with permission of the landowner or the landowner's designee. The intent of the regulations is to prevent unsolicited vendors on public and private property, where in certain cases those sales may pose a life-safety concern or nuisance to the vendor or the public.

The proposed amendment was presented to the Planning Commission on April 2, 2024. The Commission unanimously approved a resolution recommending City Council approval of the UDO amendment. City Council approved CB-2019 for public hearing at the April 8, 2024 regular meeting.

BUDGET/TIME IMPLICATIONS

There are no time or financial impacts to the City.

Staff recommends approval of CB-2019 on second reading.

A BILL FOR AN ORDINANCE AMENDING SECTION 11-3-3(e)(1) ADDRESSING COMMERCIAL USES UNDER THE CITY OF NORTHGLENN UNIFIED DEVELOPMENT ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 11-3-3(e)(1) of the City of Northglenn Municipal Code is amended to read as follows:

(1) Commercial Uses, Generally. ~~Commercial uses shall take place entirely within enclosed buildings and all merchandise, either for sale or display, shall be kept or stored entirely within completely enclosed structures, unless otherwise indicated.~~

(A) Commercial uses shall take place entirely within enclosed buildings and all merchandise, either for sale or display, shall be kept or stored entirely within completely enclosed structures, unless otherwise indicated; AND

(B) NO COMMERCIAL USE, INCLUDING THE STORAGE OF GOODS, MAY BE CONDUCTED ON PUBLIC OR PRIVATE PROPERTY IN A COMMERCIAL ZONED DISTRICT WITHOUT THE PERMISSION OF THE LANDOWNER OR THE LANDOWNER'S AUTHORIZED DESIGNEE.
