Council member Carrico reported on the Adams School District 12, the District's consideration of issuing certificates of participation (COPs) for facility improvements, filling the District 4 Board member vacancy, fund raising for Northglenn High STEM students to attend a national competition in Texas, and a public input project to vet new textbooks for schools. Council member Carrico reported she attended the School District and Special Olympics joint Unified Games. stating it was a great event, and announced the Northglenn Thornton Rotary had recently donated \$5,800 worth of food to area food banks. Council member Carrico spoke about the Homer and Me book program, which provides students with personalized books and workshops about making wise choices, and stated the Northglenn Thornton Rotary Club and several businesses have partnered to participate in the program. Council member Carrico thanked Dodge Signs for providing posts for the community garden project at the Stonehocker Farmhouse and reported she attended the Parry's Pizza grand opening event.

Mayor Pro Tem C. Dodge commended Mr. Steven Stokes, Event Supervisor, for his work on the Facebook page for the Pirate's Plunder event. Mayor Pro Tem Dodge reported the last A Cappella concert will be held this Friday at the D.L. Parsons Theatre and announced the Northglenn Youth Theatre will be featured in the production of "Thoroughly Modern Millie" beginning April 24th. Mayor Pro Tem Dodge recognized Mr. Michael Stricker, Recreation Programs Supervisor and Northglenn Arts & Humanities Director, for directing the production "Hysteria," which will be playing at the Boulder Ensemble Theatre.

Mayor Downing reported that students from Northglenn High School attended Coffee with the Mayor this morning and provided information about their participation in the tax assistance program. Mayor Downing reported on the Urban Drainage and Flood Control District conference she attended and information that was presented regarding global warming.

Council member W. Dodge reported he attended the Northglenn Business After Hours event and the Lunch and Learn event. Council member Dodge reported a Ward 1 meeting will be held at 6:30 p.m. on April 23rd at Leroy Drive Elementary School and noted he will be serving ice cream at the meeting. Council member Dodge reported he

had participated in the Homer and Me book program. Council member Dodge commended creator/author Kelly Kinch and stated it is a great program for students and the City.

Council member Mullica reported a Ward 3 meeting will be held on April 22nd, and encouraged residents to participate in the City's branding project.

Council member Snetzinger reported she and Council member Wieneke will be hosting a Ward 4 meeting tomorrow evening at 6:15 p.m. at Shepherd's Hall and encouraged residents to attend. Council member Snetzinger reported that Mr. Terry Moore, Executive Director of Almost Home, expressed his thanks to the City Council for the sponsorship of their Spring Out of Homelessness event. Council member Snetzinger reported that the Parks and Recreation Advisory Board meeting had been canceled due to a lack of quorum, and encouraged residents to consider serving on a board or commission to fill current vacancies.

City Clerk Small reported that information has been prepared for those interested in being a City Council candidate in the November 3, 2015 municipal election, and stated copies of the 2015 Candidate Manual are available in the City Clerk's office and will soon be available on the City's website.

City Attorney Hoffmann reported on House Bill 15-1348, stating the legislation would have a negative impact on urban renewal. City Attorney Hoffmann stated the first hearing on the bill is scheduled for this Wednesday and provided information about the proposed legislation.
