Council member Carrico reported on the Police Department's recent shred event and the Malley Drive Elementary School 50<sup>th</sup> Anniversary celebration. Council member Carrico commended music teacher Jean Madsen for her work at Malley Drive Elementary, and reported on the Backpacks to Briefcases event she attended. Council member Carrico announced CPR classes are available through the North Metro Fire Rescue District and noted more information is available on the District's website.
