Northglenn Youth Commission

Youth Commission Members Connor Mercer, Peyton Larsen, and Claudia Dodge presented the Northglenn Youth Commission 2014 Annual Report to City Council. Connor reported on the membership of the Commission and events including the Farmers Highline Canal Cleanup and the Colorado 9 to 25 Youth Summit. Claudia reported on the Commission's participation in events including Safe Street Halloween and Noel Northglenn. Peyton spoke about activities of the Commission including the May Mayhem dodge ball tournament and the Fireworks and Flapjacks race at the July 4th Festival.

City Council commended the Youth Commission members on their leadership and efforts and thanked the Commission for participating in community events.

PUBLIC HEARINGS:

CB-1844 – Glenn Arms Apartments PUD Amendment

City Clerk Small read the title.

Mayor Downing opened the public hearing on CB-1844 and read an opening statement regarding the hearing on the rezoning application for the property located at 301 Malley Drive. There were no objections to the jurisdiction or procedures of the hearing.

Ms. Becky Smith, City of Northglenn Planner, presented information about the request to amend the Planned Unit Development (PUD) for the Glenn Arms Apartments located at 301 Malley Drive. Ms. Smith spoke about the proposed rezoning and parking requirements for the property and stated the Planning Commission recommended approval of the rezoning request. Ms. Smith addressed questions from Council regarding the parking requirements for the development.

Ms. Blair Lichtenfels, legal counsel for the applicant, spoke about the request to amend the Glenn Arms Apartments PUD, which would reduce the number of parking spaces and provide more flexible design guidelines for the Aspen Park Apartments.

Mr. Max Bresnar, BMC Investments, provided information about BMC Investments and their property management companies, and spoke about the Aspen Park Apartments. Mr. Bresnar addressed questions from Council regarding the parking spaces for the development and stated an analysis had determined that the original parking requirements contained in the Glenn Arms Apartments PUD could not be met with the existing space.

Mr. Steve Tuttle, Fox Tuttle Transportation Group, provided information about the technical analysis that was performed regarding the parking space requirements.

Mayor Downing called for anyone opposing the rezoning application to come forward. There was no response.

Mayor Downing called for any other interested person wishing to speak about the rezoning application to come forward. No one came forward.

Ms. Lichtenfels asked Council to approve the PUD amendment based on the requirements of the Northglenn Zoning Code and stated the proposed PUD amendment conforms to the City's Comprehensive Plan.

Mayor Downing closed the public hearing on CB-1844.
