SUBJECT: CR #5 - 2015 Replacement Vehicles; (4) Patrol, (1) Investigations, (1) Animal Control.

#### **RECOMMENDATION:**

Attached to this memorandum is a Resolution seeking the Council's approval to issue Purchase Orders to Spradley Barr Ford Lincoln of Greeley, Inc., and, Sill-Terhar Motors, Inc. for the purchase of replacement police, animal control, planning department and City Manager's office vehicles.

The Patrol vehicles being recommended for replacement are Units #206, #216, #244 and #248; Investigations vehicle Unit #286; Animal Control vehicle Unit #307; Planning Department vehicle Unit #278; and, City Manager's Office vehicle Unit #282 as indicated on attached Vehicle Replacement Criteria sheet. The above vehicles were rated as follows:

- Unit 206 Rated 13
- Unit 216 Rated 12
- Unit 244 Rated 12
- Unit 248 Rated 14
- Unit 286 Rated 14
- Unit 307 Rated 10
- Unit 278 Rated 10
- Unit 282 Rated 11

#### **BACKGROUND:**

The purchase of four (4) 2015 Ford Utility Police Interceptor SUV's are quoted at the price of \$31,637.00 each from the State of Colorado price agreement, bid number 201500000000207; the three (3) 2015 Ford Fushion Hybrid's are quoted at the price of \$23,189.00 each from the State of Colorado price agreement, bid number 201500000000210; and, the 2015 Ford ¾ ton F250 Extended Cab Shortbed Pickup Truck is quoted at the price of \$36,610.00 from the State of Colorado price agreement, bid number 201500000000210.

The Police Department initially submitted budget packet requests for the purchase of two (2) 2015 Ford Sedan Interceptors and two (2) 2015 Ford Utility Interceptor SUV's; however, after having an opportunity to evaluate the recently delivered 2014 Ford Utility Interceptor SUV's, it was decided to order all four new 2015 Ford's as SUV's, instead of two of the sedans. During the evaluation of the new

Ford SUV's, it was determined the all-wheel drive vehicles are easier to drive and handle, have more driving compartment space for officers of all sizes, and have more storage space and functionality than the smaller Ford Interceptor Taurus sedans. The cost difference for the upgrade on two of the sedans to SUV's is \$1,200.00 total which is our desired choice on these vehicles. This is a cost which can be absorbed in the 2015 Police Department – Administration Division – Capital Outlay approved budget.

The total amount for these two Purchase Orders is not to exceed \$232,725.00. The cutoff date for the ordering of these replacement vehicles is prior to March 1, 2015.

#### **BUDGET IMPLICATIONS:**

Council previously approved funding for these purchases in the 2015 Budget – Police Administration – Capital Outlay fund; 2015 Budget – Planning & Development – Capital Outlay fund; and, 2015 Budget – City Manager – Capital Outlay fund. Appropriate account codes will be utilized by each of the three Departments to cover the two Purchase Orders for these replacement vehicles.
